Oil slips as US stocks rise

London, October 23

Oil prices slipped towards \$59 a barrel on Wednesday on data showing a bigger-than-expected rise in US crude stocks, while the prospect of deeper output cuts by OPEC and its allies offered support.

Brent crude futures were down 47 cents, or 0.79 per cent, to \$59.23 a barrel at 1130 GMT. West Texas Intermediate (WTI) crude futures for December delivery fell 56 cents, or 1.03 per cent, to \$53.92 per barrel.

US crude stocks rose by 4.5 million barrels to 437 million barrels in the week ended October 18, compared with analysts' expectations for a gain of 2.2 million barrels, data from industry group the American Petroleum Institute showed.

Inventory data from the US Energy Information Administration (EIA) is due later on Wednesday.

OPEC output cut

Helping underpin prices, the Organization of the Petroleum Exporting Countries (OPEC) is mulling whether to

deepen production cuts amid concerns of weak demand growth next year.

Some analysts were sceptical of OPEC's ability to further cut output.

"It will be a struggle to get members to cut a significant amount more, particularly if you have some members who are not pulling their weight when it comes to cuts," Dutch bank ING said in a note.

Meanwhile, easing trade tensions between China and the US, the world's two largest economies and biggest oil consumers, were also helping to cushion overall sentiment for oil, traders said.
