No Plans to Merge Vedanta with Parent Co: Anil Agarwal

Says Vedanta will only provide mgmt expertise, seek equity partners to fund bid for BPCL

Mumbai: There are no plans to merge Vedanta Ltd with its London-based indebted parent Vedanta Resources, billionaire Anil Agarwal said on Wednesday, a day after his company scrapped its proposed restructuring plans that had envisaged independent listings for three separate businesses. "I want to make it very clear to the market," the Vedanta chairman told ET in an intervi-

ew. "We are not going to do that." Agarwal stressed that while the company plans to bid for staterun Bharat Petroleum (BPCL) as and when it goes on the block, the funds won't come from Vedanta but private equity partners. The-

'Videocon was sealed, signed and delivered. It was very clear that the CoC was the final authority," Agarwal said. "We had made a very lucrative offer. I believe we were the highest bidder."

Jindal Power, Adani **Realty Firm Submit Eols for Videocon**

Mumbai: The resolution professional at Videocon Industries has received expressions of interest from Jindal Power and Adani Properties for the consumer durable company and its 12 units, people aware of the bankruptcy proceedings told ET.

In a parallel development, the Supreme Court is scheduled to hear on Monday an appeal by winning bidder Twin Star Technologies against a January 5 National Company Law Appellate Tribunal (NCLAT) order that prompted restart of the resolution process.

Resolution professional Abhijit Guhathakurta, backed by Deloitte, has invited firm bids by March 19 and aims to complete the resolution process by April 18. Adani Pronerties and Jindal Power did not respond to ET's queries. Venugopal Dhoot-promoted Vide-

ocon Industries has 410 acres across India, of which 234 acres are in Aurangabad. Venugopal Dhoot, along with his brothers Raj Kumar Dhoot and Pradeep Kumar Dhoot, has provided a personal guarantee of ₹26,797 crore. Lenders voted to restart the reso-

lution process after NCLAT ruled that Twin Star Technologies' plan was non-compliant with the Insolvency and Bankruptcy Code (IBC). It then reverted to the committee of creditors (CoC) to complete the resolution process.

The recovery for lenders was 4.15% of the admitted claims of ₹58,519 crore. NCLT had approved Twin Star's resolution plan only after 95% of lenders voted in favour.

Furthermore, lenders were uncomfortable when NCLAT raised questions on confidentiality of liquidation value since the offer made by Twin Star was ₹2.962 crore. marginally above the ₹2,568 crore liquidation value.

The winning bidder would also argue that once a plan is approved by the NCLT, it is binding on all the stakeholders in line with a landmark Supreme Court judgement in September on Ebix Singapore. That verdict said an NCLT-approved plan cannot be withdrawn or
