

I, S.K.Gupta, Company Secretary in practice appointed by the Board of Directors of **COMMERCIAL ENGINEERS & BODY BUILDERS CO LIMITED** (the 'Company') as a Scrutinizer for conducting the Postal Ballot process through e-voting in a fair and transparent manner in respect of the resolution contained in the Postal Ballot Notice dated 24th August, 2020, do hereby submit my Report as under:-



1. The compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder relating to Postal Ballot by the shareholders on the special resolution proposed in the Notice of the Postal Ballot is the responsibility of the management. My responsibility as a Scrutinizer is to render Scrutinizer's Report of the total votes cast through e-voting in favour or against the resolution.

2(i) Due to intermittent non-availability of postal and courier services on account of threat posed by COVID-19 pandemic situation and in accordance with the Ministry of Corporate Affairs Circular Nos. 14/2020 dated 8th April, 2020, 17 /




2020 dated 13th April, 2020 and 22/2020 dated 15th June, 2020 ('MCA Circulars') and SEBI Circular No. SEBI/HO/CFD/CMD1/ CIR/P/2020/79 dated 12th May, 2020, the Company issued a public notice by way of advertisement published on 8th August, 2020 in Financial Express (English) and in Raj Express (Hindi) giving intimation to its Members that the resolution to be passed through postal ballot / e-voting shall be sent only through electronic mode to all the Members of the Company who have registered their e-mail IDs with the Depository Participants / Registrar and Transfer Agents ("RTA") of the Company and the manner of registration of e-mail IDs by the Members (both physical and demat) who are yet to register their e-mail IDs with the Company.

- (ii) The Company has on 24th August, 2020 completed the dispatch of Postal Ballot Notice dated 24th August, 2020 by sending e-mail to its members whose e-mail addresses were registered with the Company or with the Depositories / Depository Participants or with the Company's Registrar and Transfer Agent i.e. KFin Technologies Private Limited ("KFin Tech") and whose names appear in the Register of Members / List of Beneficial Owners received from the National Securities and Depository Limited and Central Depository Services (India) Limited as on Friday, 21st August, 2020, being the "Cut-off Date" fixed for the purposes of e-voting for Postal Ballot.
3. The Company has in light of the MCA Circulars, offered facility to the members who have not registered their email address and in consequence could not receive the remote e-voting notice to temporarily get their email address registered with KFin Tech, by clicking the link: <https://karisma.kfintech.com/emailreg> and follow the registration process as guided thereafter. Post successful registration of the email address, the member would get soft copy of the Notice and the procedure for remote e-



voting along with the User Id and Password to enable remote e-voting for the Postal Ballot.

4. The physical copy of the Postal Ballot Notice along with the Postal Ballot Forms and postage pre-paid business envelopes were not sent to the Members as per the exemptions provided in the MCA Circulars mentioned above. Hence, the communication of the 'Assent' or 'Dissent' by the Members took place through the remote e-voting process only.
5. Pursuant to Rule 20 and 22(3) of the Companies (Management and Administration) Rules, 2014, the Company has also published Newspaper Advertisement on 26th August, 2020 in Financial Express (English) and on 27th August, 2020 in Raj Express (Hindi) regarding completion of dispatch of Postal Ballot Notice by e-mail and containing all the matters as required under the Companies Act, 2013 and relevant rules framed thereunder.
6. The Postal Ballot Notice along with the Explanatory Statement was uploaded on the website of the Company i.e. [https:// www.cebbco.com](https://www.cebbco.com) and on the website of the RTA i.e. KFin Tech i.e. <https://evoting.karvy.com>. The results of the Postal Ballot through remote e-voting will also be made available on these websites.
7. The Company has offered remote e-voting through M/s KFin Technologies Private Limited ('KFin Tech') and our report contains the details of voting through remote e-voting only.
8. The facility of e-voting remained open from 9.00 A.M. on Wednesday, 26th August, 2020 to 5.00 P.M. on Thursday, 24th September, 2020.




9. We have unblocked the votes cast through remote e-voting in the presence of Ms. Divya Saxena and Ms. Kamini Gupta who were not in the employment of the Company.




