Key Developments

- The Spoke hospital at Sholinganallur (OMR), Chennai commenced operations in Sep-22. The trajectory of operations here is as per our expectations
- Project work for the Spoke hospital at Financial district, Hyderabad is on schedule. The hospital is strategically located in the rapidly growing financial district of Hyderabad and will form an important part of the rainbow network in the city
- Project works for new Spoke hospitals at Central Hyderabad and Anna Nagar, Chennai are progressing well, and they are expected to commence operations during the next financial year
- Project work for an additional block with 50 beds at Hydernagar, Hyderabad is progressing well and is expected to commence operations during the next financial year
- Project work for the new Spoke hospital at Bangalore and the Regional Spoke at Rajahmundry have commenced and are expected to be completed in the next 24 months

Commenting on the performance for Q3 FY2023 Dr. Ramesh Kancharla, Chairman & Managing Director, Rainbow Children's Medicare Limited (RCML) said,

"I am pleased to inform you that the company has delivered robust quarterly performance, led by high patient footfalls across hospitals in every geography. The revenues for Q3 FY23 stood at Rs. 3064.04 mn, which is a growth of 23.17% compared to Rs. 2487.56 mn in Q3 FY22. The EBIDTA for Q3 FY23 was Rs. 1067.56 mn, which is a growth of 19.59% compared to Rs. 892.68 mn in Q3 FY22 and the PAT for Q3 FY23 was Rs. 582.44 mn, which is a growth of 28.87% compared to Rs. 451.95 mn in Q3 FY22.

We are pleased to share that the projects which are under execution are progressing well and will commence operations within the targeted timelines."

To realize its mission of providing quality pediatric healthcare throughout cities, RCML is continually working to improve its service offering. Over the next five years, the Company plans to add 1,000 beds in its target markets of Hyderabad, Bengaluru, Chennai, the National Capital Region, and Tier-2 cities in Andhra Pradesh and Tamil Nadu.

The doctors work in teams and have 24/7 commitment, which is particularly important for children's emergency, neonatal, pediatric intensive care services and to support pediatric retrieval services. The Company also operates the country's largest pediatric DNB training programme in private healthcare, offering post graduate residential DNB and fellowship programme.
