Dear Sir / Madam,

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in compliance with SEBI circular No SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated 20th May 20, we hereby inform you that:

- As already intimated vide our earlier letter dated 28th March, 2020, the operations/business
 activities at our plant and corporate office were stopped from 24th March, 2020 in pursuance
 of guidelines of Government of India against the spread of COVID-19.
- 2. Further, the Company had restarted partial operational activities at its manufacturing plant located at Thakurdwara, (UP) on 5th May, 2020 as per guidelines and approval of the respective State Government, as applicable. However the Plant is non-operational w.e.f 23rd May, 2020 i.e. today because of necessary arrangement being taken viz. sanitizing the premises, thermal screening etc. to ensure a safe working environment and further to carry out maintenance activities.
- The operations /business activities are still closed at our Corporate Office from the first day of Lockdown 1.0 and it may continue to be non-operational upto 31st May, 2020. The Company's employees are still functioning from home.
