<p>Notice is hereby given to the members of E-Land Apparel Limited ("Company") pursuant to provisions of section 96 of the Companies Act, 2013 ("Act") read with Companies (Management and Administration) Rules, 2014 as amended ("Rules"), that the 26th Annual General Meeting of the Company ("AGM") to be held on Friday, September 29, 2023 through VC/OAVM at 11:00 AM (I.S.T.) to transact the business as set out in the notice of AGM.</p> <p>The Ministry of Corporate Affairs vide General Circular No. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 5, 2020 and 10/2022 dated December 28, 2022 (collectively referred as "MCA Circulars") and the Securities and Exchange Board of India ("SEBI") vide Circular No. SEBI/HO/CFD/CMD/DIR/9/2020/79 dated May 12, 2020 and SEBI/HO/CFD/POD-3/DIR/2023/4 dated January 05, 2023 (collectively referred as "SEBI Circulars") has permitted companies to hold Annual General Meetings ("AGM") through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM"), without physical presence of the Members at a common venue and provided relaxation from dispatching of physical copy of Annual Report upto September 30, 2023.</p> <p>The Company has sent electronic copies of Annual Report along with the Notice of AGM on Thursday, September 07, 2023 to these shareholders whose email IDs are registered with the Company/Depository Participants as on the cut-off date i.e. September 01, 2023. All the members are hereby informed that:</p> <ol style="list-style-type: none"> The business, as set out in the notice of AGM, may be transacted through remote e-voting or e-voting system at the AGM. The remote e-voting period shall commence on Friday, September 26, 2023 at 9:00 A.M and shall end on Sunday, September 28, 2023 at 5:00 P.M. The cut-off date for determining eligibility to vote by remote e-voting or e-voting at the AGM shall be Friday, September 22, 2023. Any member who acquires shares of the company and become the member of the company after dispatch of notice and holding shares as of cut-off date i.e., Friday, September 22, 2023 may obtain login ID and password by sending a request at evoting@nsdl.co.in. Only those Members/ Shareholders, who will be present in the AGM through VC/OAVM facility have not casted their vote on the Resolution through remote E-voting and are otherwise not barred from doing so, shall be eligible to vote through e-voting system in the AGM. Members who have voted through Remote e-voting will be eligible to attend the AGM. However, they will not be eligible to vote at the AGM. The detailed procedure and instruction for remote e-voting and e-voting during the AGM are given in the notice of AGM. Members may note that: <ul style="list-style-type: none"> The remote e-voting shall be disabled by NSDL after the e-voting closure date and time for voting and once the vote on a resolution is cast by member, the member shall not be allowed to change it subsequently. The facility for voting at the AGM shall be made available by the NSDL. The person whose name is recorded in the register of members or in register of beneficial owners maintained by the depositories as on the cut-off date shall only be entitled to avail the facility of remote e-voting as well as voting in the AGM.
