### Freedom from the Past..!

And as we proudly hoist the flag today, imagine our surprise and consternation if the flag doesn't rise, "Hey," we shout, "Come on, we are hoisting you up. Fly free!"

"I can't!" says the flag.

"And why not?" we ask, huffing and puffing to pull the rope that holds the flag, but the flag refuses to go up!

"Because I can't leave the ground, I have too much baggage! I'm stuck!"

Now I'm going to move away from that rather grim picture I've painted for you. Two days ago, billionaire and Infosys's chairman Mr Narayana Murthy, quoted Former US President Franklin Roosevelt, who defined a true democracy as having four freedoms; freedom of expression, freedom from fear, freedom of faith, and freedom from want!

But, and do get this straight, all these four freedoms are birthed and are possible only

if we have freedom from the past. I'm going to quickly take you to the Chandrayaan-3 take-off to the moon: How glorious the take-off was, how proud we felt as a country, but lo and behold, a little later we watched concerned as something fell off the rocket, and a little later some else and something more. But even as we show concern, the scientists smile, because they know that for the rocket to rise, the boosters on either side have to fall off and later other parts too, to allow the rocket to rise, go faster and finally land on the moon.

## Injury-recovered players may return for Asia Cup: Dravid

Florida, Aug 15: Team India Coach Rahul Dravid hinted at a few injured players making a comeback into the side for the Asia Cup.

"We have a few guys coming back from injuries in any case. We have to give them opportunities to play (in Asia Cup)," he told

BCCI tv in post-match conference.

Dravid's comments come in the wake of K.L. Rahul and Shreyas Iyer undergoing fitness training at the National Cricket Academy in Bengaluru.

Shreyas had suffered a back injury during the Test series against Australia earlier this year whereas Rahul sustained a thigh injury during the IPL 2023.

Both are recuperating after undergoing

surgeries at the NCA, but there has not been any confirmation on their return into the national team. However, they might be a part of the preparation camp for Asia Cup at NCA, beginning August 23.

## Chennaiyin beat Tribhuvan 3-0, enter Durand last 4

Guwahati, Aug 15: Chennaiyin FC have continued their dominance in the ongoing Durand Cup 2023 with a commanding 3-0 victory against Tribhuvan Army to advance to the quarterfinals at the Indira Gandhi Athletic Stadium here on Monday.

The opening goal was scored in the 22nd minute after Connor Shields set up winger Farukh Choudhary with a precise pass as the Indian forward scored his first goal for the club. Rahim Ali then extended the lead with his goal from the penalty spot in the 39th minute before Rafael Crivellaro struck in the 83rd minute to

seal the victory for his side. Owen Coyle's men began the match with high intensity and came close to breaking the deadlock in the 9th minute when a cross from Connor Shields found Farukh Choudhary for an instant attempt that narrowly missed its mark. Chennaiyin FC's relentless pursuit paid off in the 22nd minute when Shields played an accurate cut-back pass to Farukh who deftly put the ball in the back of the net to score his debut goal for the club.
