Dear Board members,

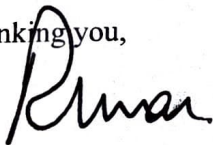
At the outset, I wish to thank Pearl Global Industries Limited for giving me the opportunity to serve as an Independent Director on its Board.
