Review report to the Board of Directors of ALPA LABORATORIES LIMITED,

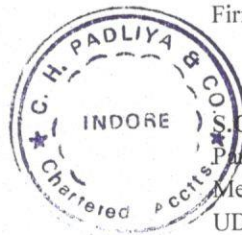

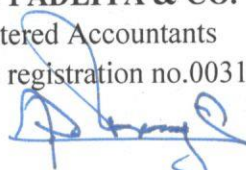
