**LARGEST SINGLE ORDER EVER RECEIVED**

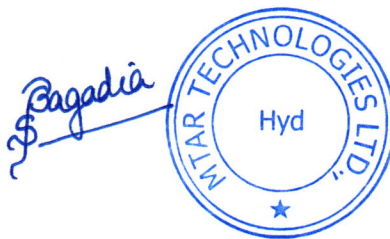
