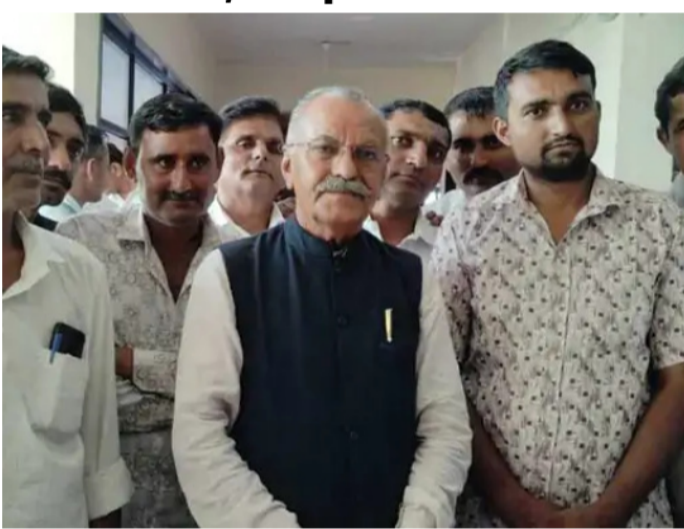

**Ujjivan Small Finance Bank observes Vigilance Awareness Week**

**November 5 said Patil to be removed, suspended on 10th**



Palanpur, Two days before the polling for the Vav assembly by-election, the BJP party has taken strict action. The BJP has suspended five leaders from the party, including Mavji Patel, who rebelled with the BJP in the by-election and contested as an independent candidate for anti-party activities. Apart from this, BJP leaders and former chairman of Bhabhar Market Yard Laljibhai Patel, Devjibhai Patel, Dalarambhai Patel and Jamabhai Patel have also been suspended from primary membership of the party. Mavji Patel said on November 5 that Patil's power is to be removed. He has been suspended from the party on November 10, 5 days after this statement.

BJP will suffer, Congress has no place: Mavji Patel  
Independent candidate Mavjibhai Patel addressed a meeting in Akoli village of Vav, in which he said about the Home Minister's visit to Banaskantha and Khas Vav, I was a soldier of BJP, I asked for a ticket, but ignoring this will be heavy for BJP now. The Home Minister who has to make an appointment to meet the Home Minister has been visiting the villages of Vava for two days. The Minister of State for Home, who does not have time to meet people, has to go door to door asking for votes. Apart from this, Mavji Patel also challenged CR Patil. Attacking the Congress, Mavji Patel said that the Congress has been in power in the Vav assembly for the past seven years, but there has been no development and now MPs have also been elected from the Congress, but there is no seat for the Congress.

Doesn't Patil know about the ticket given to me in the past? Describing his work, he says that here I have worked for Parbat Patel in the Lok Sabha. Shankar Chaudhary has been selected and sent. Helped for Rakhaben too. I have held the responsibility of an activist and MLA here. 4 parties in this country have given me ticket so much they don't mind? We actually went not to ask for tickets, but to win seats. We were doing all this with the idea of ??making the party bigger, but they didn't like it. The people are removing the power of the party chief  
You said in the public meeting that this is a war to

remove the power of Patil. What do you want to clarify behind making this statement? In response to that question, he said that the power of the party chief is taken by the people. When a party is egotistical, its power is lower. Otherwise there is no reason not to give me a ticket. If I lose the election, the party has a majority of 162 MLAs.  
Who is mavji patel?  
Disgruntled BJP leader Mavji Patel has filed an independent candidature for the Vav Assembly by-election after not getting a ticket. Mavjibhai Patel has led the Tharad Vav Legislative Assembly. He has previously been on the 20-point Implementation High Power Committee. He played a leading role for farmers across Gujarat in getting farmers' tractor trolleys treated as bullock carts and exempted from tax. Earlier Chief Minister late Chimanbhai Patel was a special confidant of Chimanbhai Patel in the government. A very important work was done by Mavjibhai Patel at that time to include the backward communities in Bakshi Panch Samaj in Tharad-Vav Khas Banaskantha area. They are almost ready to contest as an independent if no party gives them ticket in the assembly elections. Mavjibhai Chaudhary, leader of Mavjibhai Chaudhary Samaj and an independent candidate who rebelled from BJP, has contested five assembly elections so far, in which he has won once, while he has faced defeat four times.

**Direct entry without passenger checking, no RPF and Railway Police, no CCTV anywhere from entry gate to platform**

A h m e d a b a d, Ahmedabad's Kalpur railway station is being re-developed. As a result, some trains departing from there and going to various states and cities of the country are being run from Sabarmati (Dharmanagar) railway station. So thousands of passengers travel here every day. A reality check was conducted at Sabarmati (Dharmanagar) railway station by Divya Bhaskar. In which it has come to light that passengers are being given direct entry without checking and neither Railway Police nor RPF was seen. At Sabarmati railway station, there were no CCTVs anywhere from the entry gate to the platform. At least some rickshaw pullers were seen harassing passengers outside the railway station. Amidst the movement of thousands of passengers, there was a situation where anyone could carry out criminal activities.

Queues at 5 counters for tickets. Most of the trains from Dhakkamukki Kalpur railway station to Delhi depart from this railway station now, thousands of passengers come and go to this railway station every day, in which the first to reach the railway ticket counter is a huge crowd. It was found there were five ticket counters. Still, people had to stand in queues to get tickets. Tickets were being issued through online kiosks, in which people were also jostling. There was no separate line for men and women. Despite the crowd, no railway police or RPF personnel were seen there. In the name of security, when Mindun reached the entry gate of Sabarmati (Dharmanagar) railway station, a crowd of people was seen standing outside. No CCTV was seen anywhere above the entry gate of the railway station. When entering the platform, there

were no Railway Police or RPF personnel to scan the luggage for baggage checking. People used to walk directly from the platform to the train compartment with their luggage. There are no CCTV cameras installed anywhere on the railway station from the entry gate to the platform. If there is an incident like theft or extortion of any person's belongings, there will be no evidence anywhere. A machine has been placed at the railway station to allow people to pass through, but there was no person checking. RPF and Railway Police were not seen. The Gujarat State Railway Police headquarters is located on the railway platform of Sabarmati Railway Police Station, but not a single police personnel was seen on the railway platform. Policemen of the Railway Police Force (RPF) were also not seen. The traffic of passengers was very high, but no security precautions were taken.
