Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Part A of Schedule III of said Regulations, the Company has informed you that the Committee of Creditors of the Company in its meeting held on October 17, 2023, voting result declared on October 31, 2023, has appointed M/S. ATG & CO. (Formerly Known as Pooja Anand & Associates), a Practicing Company Secretary, as the Secretarial Auditor of the Company for the Financial Year 2022-23.

As informed earlier vide our intimation dated August 03, 2023 regarding the initiation of corporate insolvency resolution process ("CIRP") in the case of CMI Limited ("the Company") under Section 7 of The Insolvency and Bankruptcy Code, 2016, filed by the Financial Creditor Canana bank and initiating the Corporate Insolvency Resolution Process under Insolvency and Bankruptcy Code, 2016 ("IBC").

The 3rd (Third) meeting of the Committee of Creditors of the Company was duly convened and conducted on Tuesday, 17th October, 2023 in New Delhi through audio-visual means. **E-voting results of the same were declared on 31st October, 2023**, approving the appointment of Secretarial Auditor of the Company. Power of the existing board is suspended and the decisions of the Company are undertaken by the Resolution Professional upon requisite approval from Committee of Creditors as and when required. The Disclosure has been submitted within the 24 hours timeframe from the date of declaration of voting results.
