KIN ALLEGE POLICE INACTION IN PREVIOUS COMPLAINT

Suraj murder: 2 held in Vadodara

SURAT, MAY 6

A DAY after murder accused Suraj Yadav, 27, was stabbed to death by two bike-borne assailants outside the Surat district court, the police arrested two key accused from Vadodara Saturday. Meanwhile, Suraj's brother Chandan Yadav alleged that the police's inaction on his younger brother's complaint regarding death threats he received led to the broad daylight murder.

"We have caught both the accused — Karan Rajput and Dhiraj Singh — late Friday night from the Karjan area near Vadodara. Rajput wanted to avenge the murder of his gang member Durgesh Yadav who was killed by Suraj and two of his friends — Manish Jha and Sandeep Gaddi. We are trying to get more information from the accused. We have collected CCTV footage and also have taken statements of some of the eyewitnesses into Suraj's murder," Zone 3 Deputy Commissioner of Police Sagar Bagmar told The Indian Express.

He added that three criminal cases were registered against Rajput and Singh at different police stations. Suraj also has been named in one criminal case.

Suraj, a resident of the Sachin GIDC area, was on his way to appear before the Surat district court Friday afternoon when

two youths intercepted his bike and attacked him with sharp-edged weapons. While Ravi Chauhan, who was accompanying Suraj, managed to flee from the spot, the assailants got hold of the victim and inflicted repeated blows using sharp weapons killing him on the spot on the main road at Parle Point in Surat.

Suraj's father Indrajeet Yadav, who had arrived in Surat from Delhi Friday morning to follow his son's bail conditions, has lodged a complaint naming Rajput and Singh at the Umra police station. The complaint states that Suraj used to live with his elder brother Chandan who works at AIIMS Delhi.

Surat: Suraj Yadav died of 37 injuries inflicted by at least two sharp weapons, said a doctor who was part of the team that conducted the post-mortem.

The post-mortem was carried out by a panel of seven doctors of the Forensic Medicine Department at New Civil Hospital Saturday. The process started at 11.30 am and lasted for three to four hours. "Two weapons were used — one had a width of 2.5 centimetre, while the other was 4 centimetres wide. Both hands

had five injuries, which indicate that he was defending himself from the blows. There are seven injuries in the throat and neck region, while the remaining deep injuries are on his chest and abdomen. The liver, intestines and trachea were damaged which was the cause of his death," said a doctor on condition of anonymity.

After the post-mortem, Suraj's body was handed over to the relatives for carrying out final rites Saturday afternoon. ENS

bail around three months ago, he used to get regular threat calls and messages from Rajput. Suraj had shared a few such WhatsApp call recordings and messages with me. They also demanded money from him. We had complained to Sachin GIDC police regarding the threat messages, but no action was taken. If the police had taken timely action, my brother would have been saved," Chandan, who arrived in Surat Friday night after learning about his younger brother's murder, said.

DCP Bagmar said, "We have sought details from Sachin GIDC police station with respect to the application given by Suraj Yadav."

Chandan added that Suraj used to be present on all dates of

case proceedings before Surat district court after being out on bail. "Earlier, he used to be accompanied by five to six youths in his own car, but Friday, his car was sent to the garage for repair. So, he left with Ravi Chauhan on a bullet (bike) to the court," he said.

Chandan alleged that Durgesh used to pressurise Suraj to join the Karan Rajput gang. However, Suraj turned down the request. "Suraj's clout was growing in the area and this made Karan jealous," Chandan said.

According to police sources, Durgesh used to regularly threaten Suraj. As a result, Suraj, along with Manish Jha and Sandeep Gaddi, allegedly eliminated Durgesh on August 22 last year.
