The voting period for remote e-voting commenced on Wednesday, 8<sup>th</sup> March, 2023 (9:00 AM) (IST) and ends on Thursday, 6<sup>th</sup> April, 2023 (5:00 PM) (IST) and thereafter the NSDL e-voting platform was blocked. Votes cast through remote e-voting were then
