In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that we have participated in a tender floated by Oil Marketing Companies (OMCs) vide dated 12th November 2021 inviting various molasses and grain based distilleries for supplying Ethanol for the period commencing from 01st December 2021 till 30th November 2022 at their various locations across the country.

Accordingly after the closure of the first round of offerings, we have been allocated as per our offered quantity of 9.68 crores litres of Ethanol from our 3 manufacturing units at Bihar, West Bengal and Haryana. The unit located at West Bengal will initiate the supply once commercial production at the enhanced capacity commences.

The per unit rate of Ethanol made from Damaged Food Grains has been fixed at Rs.52.92/- per litre with an increase of 2.65% from previous year, the rate for Ethanol made from Surplus Food Grains remains unchanged.
