## India likely to unveil fertilizer subsidy bill in shorter time

 New Delhi/Mumbai, January 14

INDIA IS LIKELY to overshoot its fertiliser subsidy bill for the current financial year by \$4.2 billion (₹30,000 crore), three sources with direct knowledge of the matter said, and the government could tap public sector banks to fund the extra spending.

The government budgeted ₹70,080 crore for fertiliser subsidies for the 2018-19, but the sources said nearly half of the money was used to settle dues from the previous year.

A rise in fertiliser prices overseas and a fall in the rupee also made imported fertilisers more expensive, lifting the total subsidy requirement for
