EC accepts parties' demand, defers Punjab polls by 6 days

Earlier date of February 14 clashed with Guru Ravidas Jayanti celebrations

New Delhi, 17 January

Accepting a demand by the state government and various political parties, the Election Commission (EC), on Monday, decided to hold the single-phase assembly polls in Punjab on February 20 instead of February 14 in view of Guru Ravidas Jayanti.

Punjab chief minister Charanjit Singh Channi, BJP and its allies, the BSP and other organisations had urged the poll panel to postpone the date of voting as lakhs of followers of Guru Ravidas travel to Varanasi in Uttar Pradesh to celebrate his birth anniversary on February 16.

In a statement, the Commission said polls would now be held on February 20. It coincides with the third phase of polling in Uttar Pradesh.

The parties had said that several followers of Guru

Ravidas would not be able to exercise their franchise on February 14 as they would be travelling for the festivities.

Sources in the poll panel said there have been precedents when the EC had rescheduled assembly polls

and bypolls after announcing the election schedule.

In October 2013, the EC had tweaked certain dates for the assembly polls in Mizoram to be held in November 2013.

A bye-election, again in Mizoram, in April 2014 was

rescheduled and the date of phase one of Uttar Pradesh assembly elections was changed in March 2012 due to similar reasons, including religious beliefs of voters and the then prevailing law and order situation.

The EC statement said that after consideration of all facts made available, it had announced the schedule for Punjab assembly polls on January 8 under which notification for the election was to be issued on January 21.

According to the earlier schedule, single-phase polls in Uttarakhand, Punjab and Goa were to be held together on February 14. It noted that the EC has received several representations from the state government, political parties and other organisations drawing attention towards the movement of a large number of devotees from Punjab to Varanasi for Guru Ravidas Jayanti celebrations on February 16.

Enter into a contract with firm to demolish twin-towers in a week: SC

The Supreme Court (SC), on Monday, directed real estate major Supertech Ltd to execute a contract within a week with a company to demolish its twin 40-storey towers in its Emerald Court project in Noida.

The Noida authority informed the bench that it has finalised the company Edifice Engineering for demolishing the twin towers in consultation with CBRI Parag Tripathi, senior counsel, appearing on behalf of Supertech Ltd.

The top court also directed Supertech Ltd to make the refund payments to the home buyers without prejudice to their rights and contentions. A bench of Justices DY Chandrachud and Surya Kant told senior advocate Parag Tripathi,

appearing for Supertech Ltd., "The contract (with a demolishing agency) shall be executed no later within a period of one week from today".

The bench noted in its order, "Advocate Ravindra Kumar, appearing on behalf of Noida states that the agency which is to carry out the work of demolition has been finalised in consultation with CBRI Parag Tripathi, senior counsel, appearing on behalf of Supertech Ltd. states that there are no objections to the agency, which has been finalised and the developer would be applying for all necessary no objection certificates (NOC) within a period of one week. The

application for NOCs shall also be marked to Noida authorities".

The top court refused to give more time to Supertech Ltd for entering into a contract with Edifice despite the repeated insistence of Tripathi saying that the NOCs can be obtained subsequently.

Tripathi submitted that the court can give one week for applying for NOC and Supertech will enter into the contract within two weeks. "I have already placed EOI which has terms of the contract. I just need the NOC, which the agency wants. It is the agency which has said that you please get the NOC. I have no difficulty in entering into contract"

"No, you don't need two weeks to enter into a contract. You apply for the NOCs in the week thereafter. All authorities will grant you NOCs, it's a direct order from the Supreme Court. We will list it after two weeks for compliance".

However, aggregate demand conditions remain resilient, it said. The issuance of e-way bills surged to 72 million in December, the second highest in its history, indicating "the likelihood of robust collection of goods and services tax (GST) in January 2022".

With a strong pick-up in manufacturing and construction, highway toll collections soared by 16 per cent month-on-month (m-o-m) in December. Power consumption rose by 4.5 per cent to 110.3 billion units in December," it said.

The Centre for Monitoring Indian Economy (CMIE) data suggested that the labour participation rate turned up to 40.9 per cent in December, the highest since September 2020. The employment rate also

improved by 23 basis points, though the unemployment rate worsened to 7.9 per cent in December from 7.0 per cent a month ago.

Export growth was also broad-based, and 10 major commodity groups recorded an expansion above their pre-Covid levels.

Inflation, meanwhile, rose due to unfavorable base effects between November and December, the RBI observed.

Take, for instance, the case of US-based hedge fund Par Capital Management, which has holdings in some top airline stocks around the world and has invested around ₹40 crore in the company.

Founded by two former airline analysts, Paul Reeder and Edward Shapiro, the group holds positions in multiple airlines like Delta Airlines, United Airlines, Southwest, and Sun Country, and new-age travel companies like Uber.

Well-known corporate lawyer Berjis Desai, former managing partner at law firm JSA, has invested in the airline.

Desai said his investment was on the basis of trust in Jhunjhunwala's business acumen and a belief that the next five years would be a boom for low-cost airlines.

Desai said veterans of the aviation industry like Aditya Ghosh being part of the team increased his confidence.

"I have made a small investment. I understand aviation is a high-risk, high-reward busi-

ness and generally people are cynical about it. But I believe there will be a boom for low-cost airlines in next five-seven years. It is a bet on Jhunjhunwala's business acumen," said Desai.

Veteran fund manager Madhu Kela is one more marquee backer of the airline with an investment of around ₹4.5 crore. Kela, during his days at Reliance Capital, had become a go-to person for investors to identify companies at an early stage -- the ones, in future, were to give multiple returns. Sources said the relationship of mutual trust with Jhunjhunwala drew him to invest in the company.

Dube, who had worked in Delta and distribution firm Sabre, has drawn multiple HNI (high-net-worth individual) C suite veterans like former Sabre executive Ninan Chacko and founder of online real estate portal PropTiger Kartik Varma to the list of investors.

"After Covid there will be a boom in travel and airline will be one of the primary winners of this boom," said an HNI who has invested in Akasa.

Dube is finalising the structure of the board as part of the process to get an air operator's permit for its first flight in May. He said the investors had come on board with the belief that the company could make money despite being in a market like India where airlines found it difficult to increase ticket prices and generate profit.

"My view is if done correctly, it could have a sustained level of profitability. We are fortunate to have the right quality of investors who have entered with similar thoughts that if done correctly, over time it will generate profits for them," Dube said.

There was no response from Jhunjhunwala to emailed and text queries on the subject.

The interest from multiple backers in Akasa comes at a time when airlines, hit by two consecutive years of the pandemic, are scouring for funds.

According to rating agency CRISIL, Indian airlines are expected to post a record loss of over ₹20,000 crore this financial year because of the third wave and higher aviation turbine fuel prices.
