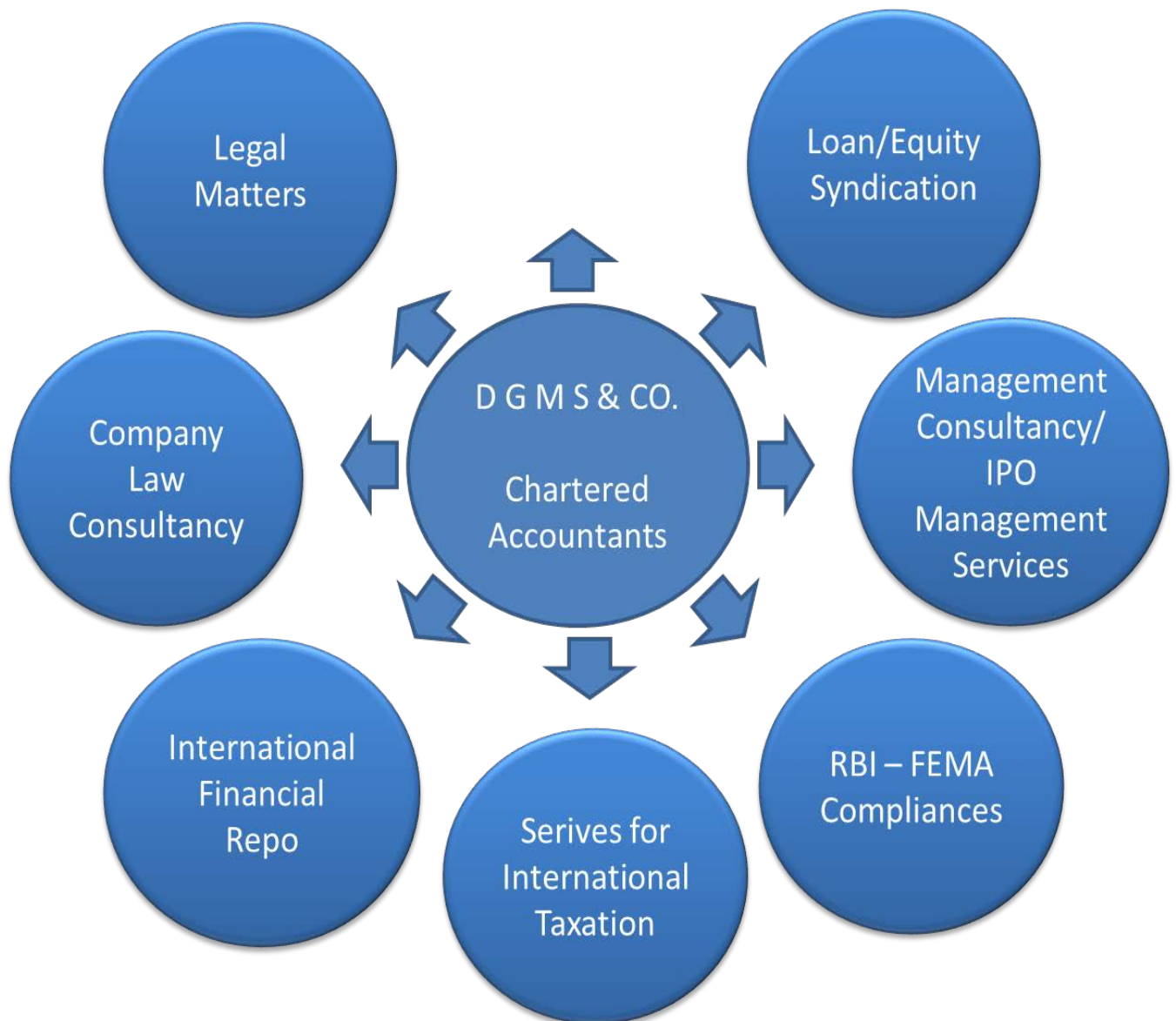
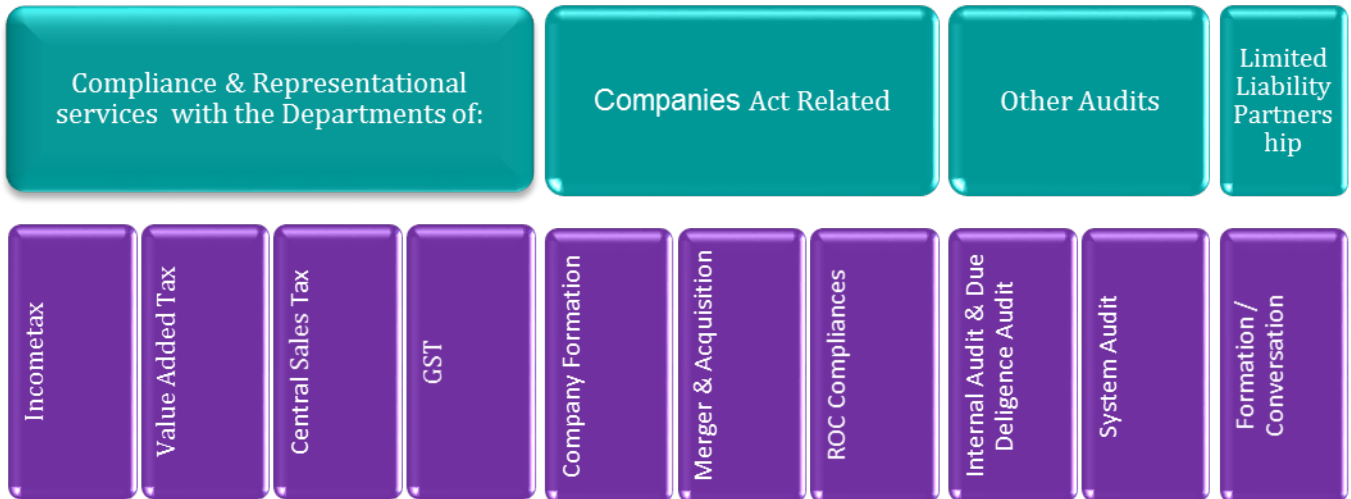


Figure 1 : Summary of Services being rendered

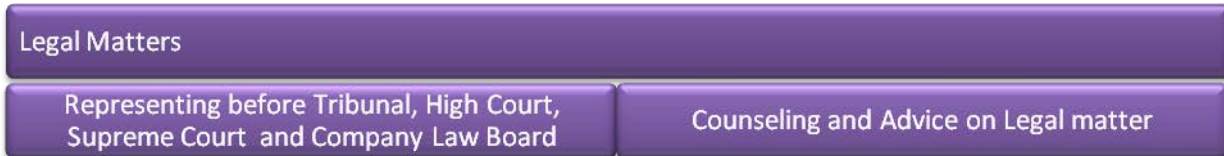

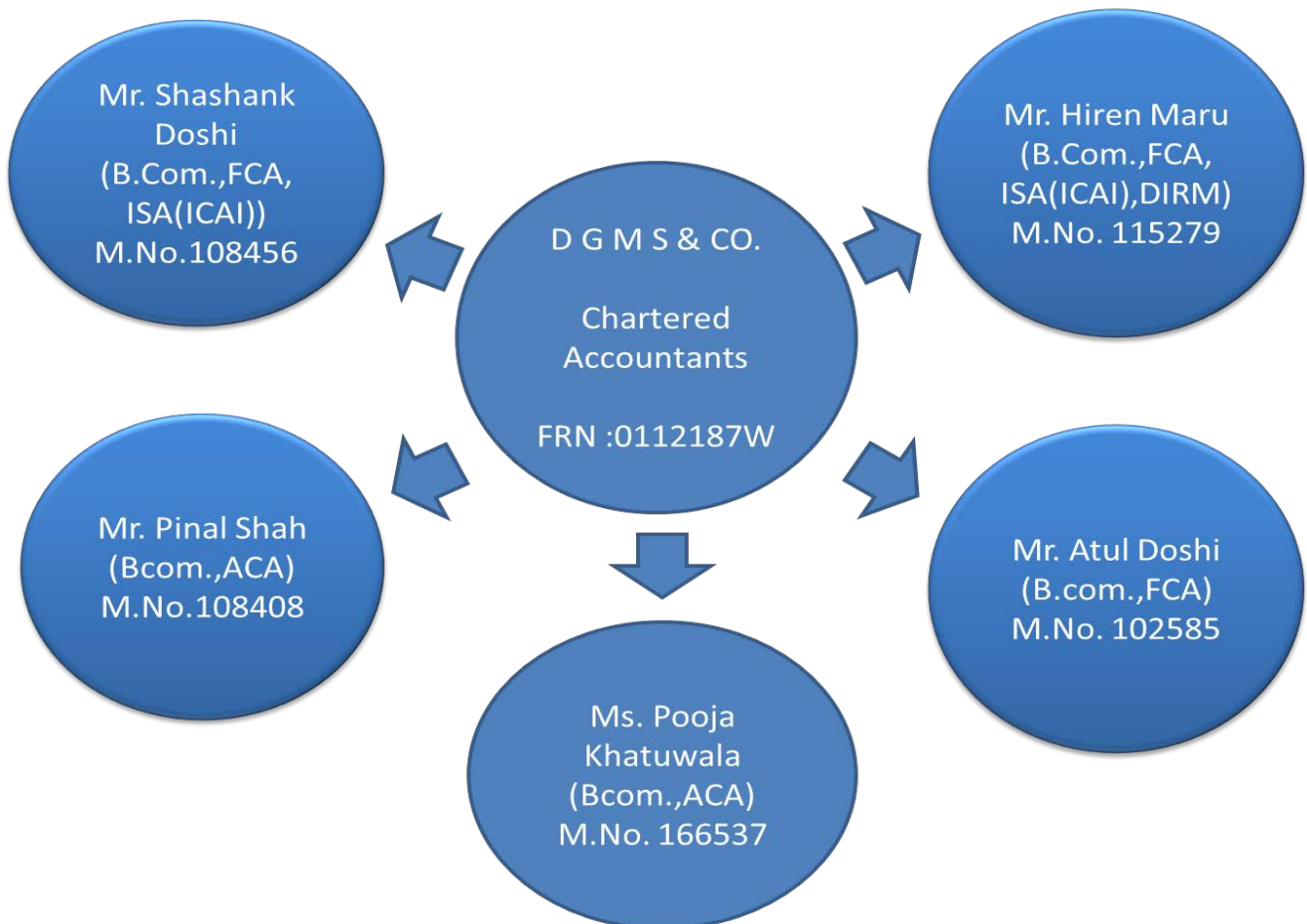


Figure 2: Composition of Partnership Firm

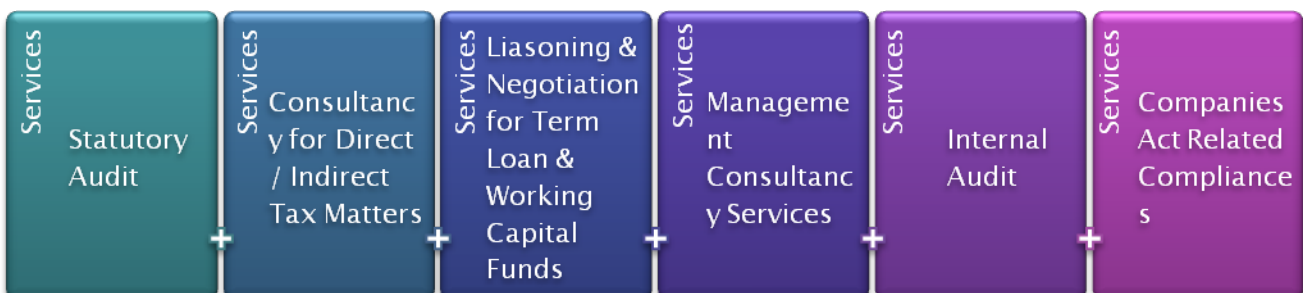


