Man stabs to death his estranged wife

RAJKOT: A 35-year-old man was arrested for stabbing his estranged wife to death on the occasion of Diwali, assaulting her parents and kin in Bhavnagar on Monday night.

Police arrested Himmat Jogadiva for the murder of his wife Dipti (32) based on a complaint filed by Praggi Gilar (60), father of the deceased. According to Gilar's police complaint, he, his wife Shantu, his sister Samu and other relatives had come to Himmat's house on Monday night on the occasion of Diwali to bless the couple and hand over gifts.

But, somehow, Himmat and his family members did not appreciate the gesture and entered into a heated argument with them. Himmat started hurling abuses at his in-laws. He went inside the house and came out with a knife and attacked Gilar and his wife. When Dipti tried to intervene, Himmat stabbed her in the chest, killing her on the spot. Himmat, his mother Lakhuben and brother-in-law Kalo alias Girish, attacked Dipti's family members and injured them.

Govt starts procuring farm produce at MSP

Rajkot: The state government has started procuring farm produce at minimum support price (MSP) from farmers. State agriculture and animal husbandry minister Raghavi Patel initiated the procurement of farm produce in Rajkot marketing yard on Saturday, the Labh Pacham day, addressing media persons, the minister said in Rajkot district 9,255 farmers

had registered themselves for selling groundnut at MSP and this will be procured at 11 centres. The government will procure various farm produce like groundnut, soybean and mung at MSP.
