**INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM
FINANCIAL RESULTS**

**To The Board of Directors of

1. We have reviewed the accompanying Statement of Unaudited Financial Results ('the statement') of **ADITYA SPINNERS LIMITED** ('the company') for the quarter ended December 31, 2018, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 05, 2016.
