**Notes :**

1. The Audit Committee has reviewed the above results and the Board of Directors has approved the above results at their respective meetings held on 13<sup>th</sup> February, 2020. The Statutory Auditors of the Company have carried out a Limited Review of the aforesaid results.
2. The Company has adopted Ind AS 116, effective annual reporting period beginning 1st April, 2019 and applied the standard to its leases, retrospectively, with the cumulative effect of initially applying the Standard, recognised on the date of initial application (1st April, 2019). Accordingly, the Company has not restated comparative Information. This has resulted in recognizing lease liability and equal amount of right of use assets as on 1st April, 2019. The adoption of the standard does not have any material impact to the financial results.
3. The Company has, on a reallocation of finance cost amongst textile and realstate and related division, has effective from 01<sup>st</sup> April, 2019 considered ₹ 484.86 lakh as recoverable from the Developer. The effect thereof has been considered in current quarter. The Developer has agreed to reimburse the said cost to the Company.
4. On 31<sup>st</sup> January, 2020 there was a fire at one of the sheds at Dhamni Factory. The company is yet to ascertain the quantum of damage wherein a few looms/ equipments were damaged. However the impact of the fire in operations is not expected to have any material bearing on the production and the projected profitability and operations at the plant are not affected. The estimated losses are adequately covered by Insurance.
5. The Board of Directors have considered and approved declaration of Interim Dividend of ₹ 1.75 per equity share of ₹ 5 each for the Financial Year 2019-20.
6. 2. The preparation of the Statement in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" (Ind AS 34) prescribed under Section 133 of the Companies Act, 2013 read with and relevant rules issued thereunder and other accounting principles generally accepted in India is the responsibility of the Company's Management and has been approved by the Board of Directors of the Company.
