Expect vote Tsunami as Tripura fed up with violence: Congress

PTI / Agartala

The Congress-Left alliance fighting the assembly elections in Tripura feels there will be a "Tsunami of votes" against the ruling BJP as people are "fed up" with five years of "continued political violence" in the border state.

Congress leader Sudip Roy Burman who was earlier health minister in the ruling BJP state government, said that the alliance did not support the demand for the proposed Greater Tripaland state and felt that in a post-political scenario, Tipra Motha, will have a "practical outlook".

"There will be a Tsunami of votes against the BJP. People are fed up with continued violence which has overshadowed any development work done by the ruling party," said Barman.

"The BJP government presented us with a Jungle Raj, the voice of the opposition was throttled, there was no rule of law. My prediction is the Congress-Left al-

liance will sweep the polls," he said.

Barman, a five-time MLA and the son of a popular former chief minister of the state, had led a group of six Congress MLAs to first join Trinamool Congress in 2016, only to move away to the BJP a year later, unhappy at the lack of interest in his state on the part of the Mamata Banerjee-led party.

His defection along with his supporters is believed to have played a crucial role in the saffron party's victory in the 2018 assembly polls.

Barman was rewarded with several heavyweight portfolios including health. But soon afterwards, he was sacked by the then chief minister Biplab Deb after political differences emerged. In February last year, he rejoined the grand old party after resigning his seat in the assembly in what observers termed a "homecoming", in the presence of Congress leaders Rahul Gandhi and Priyanka Gandhi.

Mishap in factory owned by K'taka min's kin, worker dead

According to police, Gurnath was "grilled to death on the blazing hot fumes of a boiler". The incident happened when the deceased attempted to clean the outer layer of the equipment.

The tragedy happened as the lid opened accidentally exposing the deceased to blazing fumes which killed him on the spot. The four workers, who were working in the vicinity, suffered burn injuries. The police have taken up the case for investigation. Further details were awaited.

A worker was killed and four others injured at a workplace accident in Nirani Sugars Limited in Karnataka's Bagalkot district on Friday. The factory is owned by the family members of the Large and Medium Industries Minister Murugesh Nirani.

The deceased is identified as 27-year-old Gurnath Huchchannavar, a resident of Gunnarakoppa village near Mudhol. The injured persons have been admitted to the hospital.
