Historical figures under attack after George Floyd's death

THE RAPIDLY UNFOLDING movement to pull down Confederate monuments around the US in the wake of George Floyd's death has extended to statues of slave traders, imperialists and explorers around the world, including Christopher Columbus, Cecil Rhodes and Belgium's King Leopold II.

Across Belgium, statues of Leopold II have been defaced in half a dozen cities over the king's brutal role over the Congo, where more than a century ago he forced multitudes into slavery to extract rubber, ivory and other resources for his profit.

"The Germans would not get it into their head to erect statues of Hitler and cheer them," said Mireille-Tsheusi Robert, an activist in Congo who wants Leopold statues removed from Belgian cities.

"For us, Leopold has committed a genocide." In the US, Floyd's death May 25 under the knee of a white Minneapolis police officer has led to an all-out effort to remove symbols of the Confederacy and slavery.

The Navy, the Marines and NASCAR have embraced bans on the display of the Confederate flag, and statues of rebel

heroes across the South have been vandalised or taken down, either by protesters or local authorities. Pressure is also mounting to remove such monuments from the US Capitol.

On Wednesday night, protesters pulled down a century-old statue of Confederate President Jefferson Davis in Richmond, Virginia, the former capital of the Confederacy. The 8-foot (2.4-meter) bronze figure had already been targeted for removal by city leaders, but the crowd took matters into its own hands.

The monument was a few blocks away from a towering, 61-foot-high equestrian statue of General Robert E Lee, the most revered of all Confederate leaders. Democratic governor Ralph Northam last week ordered its removal, but a judge blocked such action for now.

The spokesman for the Virginia division of the Sons of Confederate Veterans, B. Frank Earnest, condemned the toppling of "public works of art" and likened losing the Confederate statues to losing a family member.

Richmond Mayor Levar Stoney, who has proposed removing all Confederate statues in the city, asked protesters not to take matters into their own hands, for their own safety. But he indicated the Davis statue is gone for good.

झाल्या. त्यावेळी कोरोनाला लांब ठेवण्याकरिता सोशल डिस्टन्सिंग पाळण्यासाठी प्रत्येक सीटवर एक याप्रमाणे केवळ ३० प्रवाशांना आणि ५ जणांना उभ्याने प्रवासाची परवानगी देण्यात आली आहे आणि मार्क लावणे बंधनकारक करण्यात आले आहे. याची अंमलबजावणी करण्याची जबाबदारी बसेटच्या वाहक-चालकांवर सोपवून बसेट प्रशासनाने हात वर केले आहेत. मात्र हे काम चालक-वाहकांच्या आवाक्याबाहेरचे असल्याने पहिल्याच दिवशी बसेट प्रवासात सोशल डिस्टन्सिंगचे तीन-तेरा वाजले. बस प्रवाशांनी खचाखच भरून धावू लागल्या. प्रवासी वाहतुकीचे नियोजन पूर्णपणे बिघडले. अतोनात गर्दी होत असल्याने बसप्रवासात सोशल डिस्टन्सिंगचा फज्जा उडत आहे. त्यामुळे प्रवाशांना कोरोनाची लागण होण्याची भीती आहेच आणि वाहक-चालकांनाही त्याचा फटका बसू शकतो. सध्या बसेटचे वाहक-चालक संख्येने कमी आहेत. त्यामुळे 'बसेट'च्या बसचा ताफा असूनही कामगारांच्या कमतरतेमुळे त्या आगारातच उभ्या आहेत. सध्या असलेल्या कामगारांपैकी ३७५ कामगारांइतक अधिक जणांना कोरोनाची लागण झाली आहे. त्यापैकी २५५ जणांनी कोरोनावर मात केली असली तरी प्रशासनाच्या आकडेवारीनुसार आठ कामगारांच्या मृत्यूही झाला आहे.

वकिलाला होम झरंटाइन करण्यात आलं. ये सर्व चोरांच्या संपर्कात आले होते. जामीनावर रुग्णालयात दाखल केलं अटक केलेल्या आरोपीत करोनाची लक्षण आढळली होती. त्यानंतर त्याची करोना चाचणी करण्यात आली.
