જોઈન્ટ ઓપરેશનમાં ધરપકડ કરવામાં આવી છે. જોકે આ સમગ્ર હત્યાનો માસ્ટરમાઈન્ડ તો રોહિત ગોદારા હોવાનું સામે આવ્યું છે. આશંકા છે કે રોહિત ગોદારા અત્યારે કેનેડામાં રહે છે. સિંગર સિંહ મૂસેવાલાની હત્યા સાથે જોડાયેલા ગોલ્ડી બરાડ તથા બિશનોઈ સાથે રોહિત ગોદારા સંપર્કમાં છે. રોહિત ગોદારાની વીરેન્દ્રને સોંપી હતી અને સીરતને નીતિન ફોજ તથા રોહિત રાઠોડને સોપારી આપી હતી. વીરેન્દ્ર ચરણ અને ગોદારાની મુલાકાત રાજસ્થાનની એક જેલ માં થઈ હતી. સૂત્રો અનુસાર સુખદેવ સિંહ ગોગામેડીએ એક મહિલાને ન્યાય અપાવવા માટે રોહિત ગોદારા સામે બળાત્કારનો કેસ કરવામાં મહત્વપૂર્ણ ભૂમિકા ભજવી હતી,
