Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")

This is further to our intimation dated 26th March 2020 and pursuant to Regulation 30 of Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated 20th May 2020. We would like to submit the following details relating to the impact of the COVID-19 pandemic and the resultant lockdown, on the operations of the Company:

1. **Impact of the COVID-19 pandemic, schedule, if any, for restarting the operations and steps taken to ensure smooth functioning of operations:**

Impact on Business Operations: The Government of India in order to control the spread of the COVID-19 pandemic announced a nationwide Lockdown on 25th March 2020. Accordingly, we shut down our operations at all our factories and offices. Being a part of the essential services industry (packing material to dairy industries), after getting the necessary permissions from the respective authorities we started our manufacturing factories as mentioned herein below:

Kanjari Factory/ Can Factory

The Can factory at Kanjari, Dist. Kheda, and Nadiad were operational since 27th March 2020 after obtaining necessary permissions. Due to the continued restrictions in the movement of people and material by the government, initially the company is not able to operate at its optimal capacity. We are currently running at approximately 90 - 95% capacity utilisation at Company's Can Factory at Kanjari, in Dist. Kheda at Nadiad.

GIDC VU Nagar Factory / Cone Factory

The operations of Cone Factory at GIDC V U Nagar, Anand started its operations from 26th May 2020 after obtaining necessary permission from the local authorities But due to the continued restriction in the movement of people and materials from the government and negligible demand for ice cream cones from dairies and other food industries this division of the company is badly affected during the first quarter ended June30, 2020.

The Administrative office in Anand was operational since 27th March 2020, after getting the necessary permissions from the respective authorities.

Mumbai Registered office

The Company's Registered Office in Mahalaxmi, Mumbai was closed in accordance with the Government directives and has resumed working from 8th June, 2020 with limited strength, as per the various guidelines issued by the Government of Maharashtra. During lockdown all employees in our offices were working from home.

The company remains committed to the health and safety of all its employees, their families and communities in which they operate.

2. Financial resources, profitability, liquidity position, ability to service debt and other financing arrangements, assets, internal financial reporting and control and demand for products/services:

The Company is in a comfortable financial position to meet its commitments and will be able to meet all its debts obligations as they come up. Stringent cost control measures are being implemented across the organization to address any evolving situation resulting from the pandemic. The Company has secured all its assets and are in working condition. Internal financial reporting and control are adequate and operating effectively. The Company expects that the demand for its products from food processing industries will continue.

3. Estimation of the future impact of COVID-19 on its operations:

Considering the fact that the situation is exceptional and dynamic, the Company is not in a position to gauge with certainty, the future impact on its operations. However, the Company is confident about adapting to the changing business environment and respond suitably to fulfill the needs of its customers.

4. Existing contracts/agreements where non-fulfillment of the obligations by any party will have significant impact on the listed entity's business:

At present, we do not foresee any contract/agreements, where non-fulfillment of any obligations by any party, will have significant impact on the business of the Company. The Company is well positioned to fulfill its existing contracts/arrangements.
