- 1. I, Atul Kulkarni, Company Secretary in practice, have been appointed as Scrutinizer by the Board of Directors of DHRUV CONSULTANCY SERVIES LIMITED ("the Company") vide resolution dated Friday 22 March 2024 for the purpose of scrutinizing the process of voting through electronic means ("e-voting") on the resolution contained in the Postal Ballot Notice (Remote E-voting in lieu of Postal ballot) (dated Friday 22 March, 2024 ("Notice") issued in accordance with General Circular No. 14/2020, 17/2020,20/2020, 2/2021, 19/2021, 21/2021, 2/2022 dated 8 April 2020, 13 April 2020, 5 May 2020, 13 January 2021, 8 December 2021, 14 December 2021 and 5 May 2022 respectively issued by Ministry of Corporate Affairs ("MCA"), Government of India (hereinafter referred to as "MCA Circulars") held between Wednesday 03 April 2024 9.00 am. to Thursday 2 May 2024 5.00 p.m.
- 2. In compliance with the MCA Circulars and SEBI Circular dated 13 May 2022, the Notice was sent through electronic mode to equity shareholders whose email address is registered with the Company/ Registrar & Share Transfer Agent of the Company, National Securities Depository Limited ("NSDL")/ Central depository Services Limited ("CDSL")/ Depository Participants;

The said Notice was also placed on the website of the Company at: www.dhruvconsultancy.in and on the website of the Stock Exchange, i.e., BSE Limited and National Stock Exchange of India at www.bseindia.com and www.nseindia.com, respectively; and on the website of www.evoting.nsdl.com the Registrar and Share Transfer Agent of the Company, being the agency appointed by the Company to provide to its equity shareholders facility to exercise their right to vote on the resolution contained in the Notice using an electronic voting system (i) remotely, on the dates referred to in the Notice ("remote e-voting");

Administration) Rules, 2014, as amended ("Rules"). As the Scrutinizer, I have to scrutinize:

i. Process of remote e-voting;

Management's Responsibility

4. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations and Disclosure Requirements) regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility

5. My responsibility as Scrutinizer for e-voting process (i.e. remote e-voting) is restricted to making a Scrutinizers Report of the votes cast "in favour" or "against" the resolution contained in the Notice, based on the reports generated from the e-voting system provided by evoting.nsdl.com, the Registrar and Share Transfer Agent of the Company and the Agency authorized under the Rules and engaged by the Company to provide e-voting facility documents furnished to me electronically by the Company and/ or www.evoting.nsdl.com for my verification.

Cut-off date

6. The Equity Shareholders of the Company as on the "cut-off" date, as set out in the Notice, i.e., Friday, 29 March 2024 were entitled to vote on the resolutions (item nos. 1 as set out in the Notice) and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date, subject to the provisions of Articles of Association of the Company.

7. Remote e-voting process

- i. The remote e-voting period remained open from Wednesday, 03 April 2024 (09:00 a.m. IST) to Thursday, 02 Mary 2024 (5:00 p.m. IST).
- ii. The votes cast during the remote e-voting were unblocked on Thursday, 02 May 2024 at 5.41 p.m.
- iii. Thereafter, the details containing, inter alia, the list of Equity Shareholders who voted "in favour" or " against" on the resolution that was put to vote, were generated from the e-voting website of NSDL i.e., https://evoting.nsdl.com. Based on the report generated by NSDL and relied upon by me, data regarding the remote e-voting was scrutinized on test check basis.
