I have been appointed as Scrutinizer by the Board of Directors of BGIL Films & Technologies Limited ("the Company") for the purpose of scrutinizing the process of voting through electronic means ("e-voting") on the resolutions contained in the notice calling 35th Annual General Meeting ("Notice") issued in accordance with General Circular No. 14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 2/2022, 10/2022 and 9/2023 dated 8th April 2020, 13th April 2020, 5th May 2020, 13th January 2021, 14th December 2021, 5th May 2022, 28th December 2022 and 25th September 2023 respectively, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India, calling 35th AGM of the Shareholders ("the Meeting" /"AGM") through VC / OAVM. The AGM was convened on Monday, 30th September 2024 at 09:30 a.m. IST through VC / OAVM.

The company had appointed National Securities Depository Limited (NSDL) as service provider for extending the facility of electronics voting to the shareholders of the company. The service provider had provided a system for recording the votes of the shareholders electronically on all items of the business (ordinary/Special Business) transacted in the 35th Annual General Meeting of the company held on Monday, 30th September 2024 at 09:30 a.m. IST through VC / OAVM. The service provider accordingly had set-up e-voting facility on their website <https://www.evoting.nsdl.com>.


As on the cutoff date there were 11327600 Equity shares of the company. Notice of the Annual General Meeting was sent to all the shareholders through permitted mode. The notice so sent contained detailed procedure to be followed by the shareholders for casting their vote electronically as provided in clause (ix) of sub rule 3 of rule 20 of the Companies (Management and Administration) Rules, 2014 read with *General Circular No. 14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 2/2022, 10/2022 and 09/2023* dated 8th April 2020, 13th April 2020, 5th May 2020, 13th January 2021, 14th December 2021, 5th May 2022, 28th December 2022 and 25th September 2023, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India.

The cutoff date for the purpose of identifying the shareholders who will be entitled to vote on the resolution placed for the approval of the shareholders was Monday, 23rd September 2024. The e-voting facility was kept open for 3 days i.e., the voting period begins on Friday, 27th September 2023 at 09:00 a.m. IST and ends on Sunday, 29th September 2024 at 5:00 p.m. IST.

At the end of the voting period on Sunday, 29th September 2024, the voting portal of the service provider was blocked forthwith. The voting report was generated by me in the presence of Mr. Manish Jain and Mr. Himanshu Kaushik who acted as witness as prescribed in sub rule 3 (xi) of the said rule 20.

Appointment

E-voting process at the AGM: -

- a) After the time fixed for closing of the e-voting by the Chairman, the electronic system recording the e-voting (e-votes) was locked by the RTA under my instructions.
- b) The e-voting system was scrutinized on test check basis. The e-votes were reconciled with the records maintained by the Company / RTA and the authorizations lodged with the Company/ RTA on test check basis.
- c) The e-votes cast were unblocked on Thursday, 3rd October 2024 after the conclusion of the AGM.


Management's Responsibility
