- For the members who had not registered their e-mail address in the records of Company/Depositories, the Postal Ballot Notice was made available on the Company's website <u>www.eihltd.com</u>, (on the Stock Exchange websites (<u>www.bseindia.com</u> and <u>www.nseindia.com</u>) respectively and on the e-voting website of Link Intime India Private Limited (Link intime) at (https://instavote.linkintime.co.in).

- 3. The Company has issued a public notice by way of advertisement on June 18, 2022 in "Business Standard" (all editions) in English and "Eisomay" in Bengali newspapers pursuant to the provisions of Rule 22(3) of the Companies (Management and Administration) Rules, 2014.

In accordance with the notice sent to the equity shareholders/ updated on the website of the Company as well as on the Stock Exchange websites, e-voting website of Link Intime India Private Limited (Link intime) and the advertisement published, remote e-voting commenced on Monday, June 20, 2022 at 10:00 A.M. (IST) and ended on Wednesday, July 20, 2022 at 5:00 P.M. (IST).
- 5. Equity shareholders of the Company holding shares as on June 10, 2022 ("cut-off date") were entitled to vote on the resolutions as set out in the Notice.
