मराठी सांस्कृतिक धोरणाचे दहा वर्षांत पुनर्निरीक्षण नाही

माहितीच्या अधिकारात वास्तव उघड

नागपूर : महाराष्ट्र राज्य स्थापनेच्या सुवर्ण महोत्सवी वर्षाच्या पार्वर्धुमीवर दहा वर्षापूर्वी राज्याने जे सांस्कृतिक धोरण सांस्कृतिक संस्थात्मक विश्वज्ञाना विरुद्धासात न घेता तयार केल्याने अंस्तोष निर्माण झाला होता. त्या धोरणावर राज्याने गेल्या दहा वर्षांत एकाही पेशाची तरतुद केली नाही. त्या धोरणाचे मूळध्याप्रमाणे पाच वर्षांनी धोरणाचे पुनर्निरीक्षण करणे आवश्यक होते. ते ते देखील अद्याप केले नाही. धोरणासाठी तरतुद केलेल्या निधी कुठेही नाही, याची चौकशीही केली नसल्याचे माहितीच्या अधिकारात समोर आले आहे.

माहितीवरून हे वास्तव समोर आले आहे. तत्कालिन सांस्कृतिक मंत्री मंत्र्यांकडे सुमारे सात वर्षापूर्वी महाराष्ट्र सांस्कृतिक आघाडीने सर्व सूचना, मागण्या, ठराव , निवेदने धोरणात समवेशासाठी पाठवले होते. धोरणाच्या पुनर्निरीक्षणाने वेळी त्यांचा विचार करण्यात येईल असे तेव्हा म्हटले होते. पण, तसे काही झाले नाही. शासन धोरणाच्या केवळ घोषणा करते मात्र त्यावर दहा वर्षे एक पैसाही खर्च करीत नाही आणि संस्थात्मक विश्वज्ञान दिलेली आस्थासनेही पाळत नाही हे अतिशय क्लेशदायक असल्याचे अभय कोळारकर यांनी म्हटले आहे. सांस्कृतिक धोरणाबाबत आर्थिक तरतुद करण्यात आली असताना हा निधी कुठे खर्च केला, याची चौकशी झाली पाहिजे अशी मागणीही कोळारकर यांनी केली आहे.

माहिती अधिकार कार्यकर्ते अभय कोळारकर यांनी याबाबत पर्थवत व सांस्कृतिक विभागाकडे माहिती मागवली होती. त्यांच्या उत्तरात प्राप्त

मुंबई : अभिनेता सुशांतसिंह राजपूत प्रकरणात केंद्रीय अन्वेषण विभागाच्या (सीबीआय) विशेष घोषणा करताना त्यावर दहा वर्षे एक पैसाही खर्च करीत नाही आणि संस्थात्मक विश्वज्ञान दिलेली आस्थासनेही पाळत नाही हे अतिशय क्लेशदायक असल्याचे अभय कोळारकर यांनी म्हटले आहे. सांस्कृतिक धोरणाबाबत आर्थिक तरतुद करण्यात आली असताना हा निधी कुठे खर्च केला, याची चौकशी झाली पाहिजे अशी मागणीही कोळारकर यांनी केली आहे.

मुंबई : 'आयआयटी'सह इतर काही केंद्रीय संस्थांमधील प्रवेशासाठी घेण्यात येणाऱ्या राष्ट्रीय सामाईक प्रवेश परीक्षेच्या (जेईई) केंद्रापर्यंत कसे पोहोचायचे, असा प्रश्न मुंबई महागण परिषदातील विद्यार्थ्यांना पडला आहे. परीक्षा दोन दिवसांवर (१ ते ६ सप्टेंबर) आली असून विद्यार्थ्यांसाठी रेल्वे सुरू होणार की नाही, याबाबत अद्यापही संभ्रम आहे.

परीक्षा दोन दिवसांवर, मात्र रेल्वेबाबत निर्णय अद्यांतरी

सष्ट केले. जेईई मुख्य परीक्षेसाठी मुंबई आणि नवी मुंबईतील २० हजार २५६ आणि लष्करातील ७१११ विद्यार्थ्यांनी नोंदणी केली आहे. देशभरात १ ते ६ सप्टेंबर या कालावधीत ही परीक्षा होणार आहे. मात्र, परीक्षा केंद्रापर्यंत कसे पोहोचायचे, असा प्रश्न विद्यार्थ्यांना भेडसावत आहे. अनेक विद्यार्थ्यांना दूरवरची केंद्रे मिळाली आहेत. मुंबईत लोकल केवळ अत्यावश्यक सेवेतील कर्मचाऱ्यांकरिता चालविण्यात येत आहे. बसच्या फेऱ्या मर्यादित आहेत. खासगी वाहन चालक अवाच्यासव्वा भाडे घेत आहेत. सकाळी नऊच्या सत्रातील परीक्षेसाठी विद्यार्थ्यांना ७.४५ वाजेपर्यंत उपस्थित राहावे लागणार आहे. पाच मिनिटे उशीर झाल्यामुळे परीक्षेस मुकल्याचे विद्यार्थ्यांचे अनुभव आहेत. गर्दीची वेळ आणि परीक्षेपूर्वी सुमारे तासभर आधी केंद्रावर उपस्थित राहण्याची सक्ती या परिस्थितीत रेल्वेचा प्रवास अधिक सोयीचा असल्याचे पालकांचे मत आहे.

मुभा मिळणार? मुंबई आणि महागण प्रदेशातील विद्यार्थ्यांना जेईई मुख्य परीक्षा देण्यासाठी उपलब्ध रेल्वेचे प्रवास करण्याची मुभा देण्यात येईल. या संदर्भातील आदेश लावून वेळ जाईल आणि तसे रेल्वेला लेखी कठिणव्यात येईल, असे राज्य सरकारमध्ये एका उच्चपदस्थाने सांगितले.
