This is with reference to your email / letter cited above, seeking clarification / confirmation on the news item in 'Business Standard' dated 31.05.2020, captioned "BEML firming up tie-ups with 2 foreign firms", we wish to clarify as under:

1. Company vide letter Ref: CS/SEs, dated 27.05.2020, informed BSE and NSE that the Board of Directors in its 362nd meeting held on 27.05.2020 approved for signing a Memorandum of Understanding with M/s MELCO to study and decide on the possibility of setting up a Joint Venture Company with MELCO.
2. Regarding tie-up with another foreign firm for joint manufacture of Defence spares, the proposal is in discussion stage and will be informed to stock exchanges after approval of the Board for signing MoU or Agreement.
