We did not review the financial results of **INDO EDUCATION PRIVATE LTD.** (subsidiary) included in the Statement whose financial information reflects total assets of Rs. 54.15 lacs as at 30th September, 2022, total revenues of Rs. 0.21 lacs and Rs. 0.42 lacs for the quarter and half year ended 30th September, 2022 respectively, total net loss after tax of Rs. 2.53 lacs and Rs. 4.97 lacs for the quarter and half year ended 30th September, 2022 respectively, total comprehensive loss of Rs. 2.53 lacs and Rs. 4.97 lacs for the quarter and half year ended 30th September, 2022 respectively, and net cash outflows of Rs. 5.37 lacs for the half year ended 30th September, 2022, as considered in the Statement. These financial results have also not been reviewed by the subsidiary's auditor and have been furnished to us by the Company's management. Our conclusion on the Statement, and our report in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), read with SEBI Circular, in so far as it relates to the aforesaid subsidiary, is based solely on such un-reviewed management approved interim financial information. 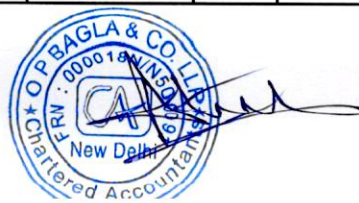
