Commencement of Commercial Production at Jammu & Kashmir Plant

Kolkata, July 11, 2019

The Indian Wood Product Co. Limited (BSE: IWP): We are pleased to inform you that upon receipt of all required permission from regulatory authorities, the trail of the Commercial Production of Premium Katha at IWP's Jammu & Kashmir Plant has commence from today i.e., July 11, 2019.

The availability of better quality of khair timber in J&K will enable IWP to produce higher quality of Katha and increase market share in the Premium Katha segment. Surplus Katha Liquor produced in J&K will be utilized in production at Baroda & Kundli units to improve the quality of Katha and also result in higher utilization of production capacity.

As per the Licence to Establish and Operate issued by the Conservator of Forest, East Circle, Jammu, IWP was required to commence the operation of plant within one year. IWP has fulfilled the license commitment within the deadline. The license is valid up to September 6, 2020.
