Once again I convey my sincere thanks to Chairman and ED for having supported me to perform my duties.

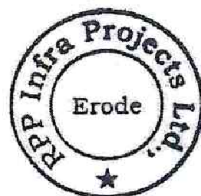




