In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and having regard to the Bank's policy on determination and disclosures of material events, it is informed that an NPA Account, viz. M/s IL & FS Financial Services Limited (IFIN) with outstanding dues of Rs.561.13 crore has been declared as fraud and reported to RBI as per regulatory requirement. Further, Bank has already made 100% provisioning as per the prescribed prudential norms and account is technically written off.
