
INVESTMENT FOR 10 MW SOLAR POWER PROJECT REQUEST FOR LEASE OF SRI LANKA PORTS AUTHORITY LAND.

This is further to our letter dated 15.11.2023 forwarded to Maaiz Transport (Pvt) Ltd., and your letter dated 27.12.2023 on the above subject.

In considering the documents submitted by both companies, we do hereby transfer the land area of 20 hectares in Lot No 1A of Survey Plan No.SK/L/139 with the same security deposit of 2.4 million, which is kept by Maaiz Transport (Pvt) Ltd., on 15.05.2023 to your Company viz., R. P. P. Infra Project (Lanka) Limited subject to below mentioned terms and condition:-

- R. P. P. Infra Project (Lanka) Limited shall enter in to a lease agreement with SLPA after obtaining all the necessary approvals including the grid availability confirmation from Ceylon Electricity Board on or before 15.02.2024.
- SLPA will take action to charge the lease rentals w.e.f. 15.02.2024.
- In the event company makes request to refund the amount deposited due to reasons beyond the control of SLPA, it will be refunded subject to recovering 2.5% of the deposited amount for administrative charges incurred by SLPA.
- Company shall take action to settle amicably any cost incurred in ejecting encroachers (if any) in the said lands.
- The investor shall avoid any new encroachments in the reserved land.
