 1. The Group has considered the possible effects that may result from the pandemic relating to COVID-19 (including its current wave) in the preparation of the results. The Group's substantial generation and transmission capabilities are tied up under medium to long term power purchase / job work / transmission agreements, which insulate revenue of the Group. Nevertheless, power sale has witnessed lower demand due to economic slowdown, and consequential impact on tariff. Based on the present assessment, the Management does not expect any medium to long-term impact on the businesses of the Group. The Group has evaluated the potential effects on the carrying amounts of property, plant and equipment, goodwill, inventory, loans and receivables since the internal and external sources of information are restricted, exercising reasonable estimates and judgments, that the carrying amounts of these assets are recoverable. Having regard to the above, and the Group's liquidity position coupled with expected future cash flows, there is no uncertainty in meeting financial obligations in the foreseeable future. The impact of COVID-19 will differ from that estimated as at the date of approval of these financial results.
