



राह घाटी में बैरागढ़-तीसा सड़क पर हुआ हादसा, चार लोग गंभीर

धर्मशाला, ११ अगस्त (जनसत्ता)।

चंबा जिले की चुराह घाटी में बैरागढ़-तीसा सड़क पर शुक्रवार सुबह तरवाई पुल के नजदीक एक टाटा सुमो गाड़ी के गहरे नाले में गिरने से भारतीय रिजर्व बटालियन (आइआरबी) के पांच जवानों और दो स्थानीय लोगों की मौत हो गई। चार लोग गंभीर रूप से घायल हैं। दुर्घटनाग्रस्त गाड़ी में बटालियन के नौ जवानों और स्थानीय चालक व एक युवक लोगों सहित ग्यारह लोग सवार थे।

जानकारी के मुताबिक मंगली निरीक्षण चौकी पर तैनात जवानों का यह दल गश्त के बाद भंजराड़ मुख्यालय लौट रहा था। इस दौरान तरवाई के पास सूमो गाड़ी अचानक पहाड़ से हुए भूस्खलन के चट्टानी मलबे की चपेट में आ गई। हादसा इतना भयानक था कि नाले में गिरने के बाद गाड़ी के परखच्चे उड़ गए। इस दौरान तीन लोग गाड़ी से छिटककर चट्टानों से टकराए। इससे उन्हें गंभीर

अक्षय चौधरी और मंगली के स्थानीय युवक पंकज को चंबा मेडिकल कालेज में दाखिल किया गया है। इस बीच मुख्यमंत्री सुखविंदर सिंह सुक्खू, राज्यपाल शिव प्रसाद शुक्ल और विधानसभा अध्यक्ष कुलदीप पठानिया ने इस सड़क हादसे पर गहरा शोक व्यक्त करते हुए मृतकों के परिजनों के प्रति संवेदनाएं जाहिर की है।
