Gist of Proceedings of the Extra-Ordinary General Meeting of Den Networks Limited

1. Date, time and venue of the Meeting:

The Extra-ordinary General Meeting of the Members of DEN Networks Limited was held on Monday, April 15, 2019 at 11.00 A.M at PHD Chamber of Commerce and Industry, PHD House, 4/2, Siri Institutional Area, August Kranti Marg, New Delhi- 110016. The meeting commenced at 11:00 AM and concluded at 11:20 AM.

2. Proceedings in brief:

Mr. Sameer Manchanda, Chairman & Managing Director, chaired the proceedings of the Meeting. The requisite quorum being present, the Chairman called the Meeting to order. The Chairman addressed the members and thereafter handed over the proceedings to Mr. Jatin Mahajan, Company Secretary of the Company. Mr. Jatin Mahajan apprised the members on proposed resolutions. Thereafter, he welcomed questions from the Shareholders and the same were clarified.
