Resilient at 77: Ajay's Inspiring Journey from Brain Blockage & Cardiac challenges to Regaining Mobility

Mumbai : Ajay, a 77-year-old male patient, was brought to Wockhardt Hospitals in Mumbai Central by his daughter. He had been apparently well, but he gradually developed difficulty in speech, heaviness in his right hand, and confusion. His relatives rushed him to the emergency room, where a code white was activated. The purpose of a Code White is to identify an actual or potential violent or out-of-control person and activate the appropriate staff to respond with a patient/person-centred and therapeutic response. An MRI of the brain was performed in the emergency room. The scan showed that there was a sudden

blockage in a blood vessel in the brain, most likely caused by a blood clot. This blockage caused a reduction in blood flow to that part of the brain. To help with this problem, experts started treatment to dissolve the blood clot. After receiving the medication, the patient was moved to the Intensive Care Unit (ICU) for further care. The patient had low oxygen levels, so he was put on a machine to help him breathe (intubated) and given medication to support his blood pressure. A test showed that his heart's pumping ability was at 45% with some problems in the movement of the heart walls. Mr. Ajay had a complicated medical history including high blood

pressure, diabetes, and had undergone angioplasty procedures in his heart. Dr Parin Sangoi, Interventional Cardiologist, Wockhardt Hospitals, Mumbai Central, performed a procedure called percutaneous transluminal coronary angioplasty (PTCA) on two of his heart arteries. Another test called coronary angiography showed that he had blockages in three of his heart vessels, so he was referred to Dr Gulshan Rohra, Cardiothoracic Surgeon, Wockhardt Hospitals, Mumbai Central who performed a coronary artery bypass graft. Dr. Gulshan Rohra, Cardiothoracic Surgeon,

Wockhardt Hospitals, Mumbai Central, said "the case of patient Ajay was a complex case with multiple comorbidities, but with the collaboration of our dedicated medical team, we were able to provide him with the necessary interventions and support. By performing the coronary artery bypass graft surgery, we aimed to improve his heart's blood flow and overall cardiac function. We monitored his progress closely, gradually reducing his dependence on ventilator support and medications, while ensuring his blood pressure remained stable. We involved a dedicated physiotherapy team to assist him with mobility

and rehabilitation." Further on this Dr Parin Sangoi, Interventional Cardiologist, Wockhardt Hospitals, Mumbai Central, added, "While age can be a factor in determining treatment options, it is not the sole determinant. Each patient is unique, and we tailor the treatment plan accordingly. Our objective is to optimize the patient's quality of life and provide them with the best chance for recovery. In Mr. Ajay's case, we are pleased to see his significant progress, as he is now able to walk with the assistance of a walker and is conscious and oriented. We will continue to monitor and support his recovery journey."
