पाली/बेणसे, दि. १२ : कोरोनाच्या संकटात जनजीवन विस्कळीत झाले. अर्थचक्र कोलमडून पडले. जगावे की मरावे या विवेचनेत जनता भरडली, अशात मात्र वाढीव विजबिलांनी कहर माजविला. सध्या वीज देयके न दिलेल्याचे वीज कनेक्शन तोडण्याचा सपाटा विद्युत महावितरणने लावला आहे. याला मराठी शाळा देखील अपवाद राहिलेल्या नाहीत. सुधागड तालुक्यातील सिद्धेश्वर (बुदुक) ग्रामपंचायतीकडून वीज देयके भरण्यासाठी मुदतवाढ मिळण्याची लेखी विनंती करूनही पाली-सुधागड महावितरणकडून काही दिवसांपूर्वी सिद्धेश्वर राजीप मराठी शाळेची वीज तोडण्यात आली आहे. तसेच ग्रामपंचायत हद्दीतील खांडसई राजीप मराठी शाळेची वीज तोडली आहे. या संदर्भात सुधागड तहसीलदार दिलीप रायन्नावार व मनसे तालुकाध्यक्ष सुनील साठे

यांच्या मध्यस्थीनंतर गुरुवारी (दि. ११) सिद्धेश्वर शाळेची वीज अखेर जोडण्यात आली आहे. मात्र शाळा ही सरकारच्या या जावातून सुटत नसतील तर ही शोकांतिका असल्याचे म्हटले जाते. सरपंच उमेश यादव सांगितले की ही शाळा १ ते ७ वी पर्यंत आहे. शाळेचे बिल भरण्यासाठी काही दिवस मुदत द्या यासाठी वीज वितरण कार्यालया विनंती करून गुरुवारी (ता. ४) लेखी निवेदन करून सुद्धा दिले होते. तरी सुद्धा शाळेचे वीज कनेक्शन तोडले आहेत. शाळांची बिले भरायची जबाबदारी ग्रामपंचायतची आहे. आणि त्याची व्यवस्था ११ व्या वित्त आयोगात केली आहे. मात्र यामध्ये ऑनलाईन पेमेंटचे समस्या आली आहे. त्यामुळे पैसे काढता येत नाहीत. हे सांगूनही शाळांची वीज कनेक्शन तोडली जात आहेत. वीज महावितरण

थकीत वीजबिल वसुलीचा दबाव समजू शकतो. शाळांना तरी यासाठी मुदत देणे गरजेचे आहे. असे देखील उमेश यादव यांनी सांगितले. या संदर्भात सुधागड मनसे तालुकाध्यक्ष सुनील साठे यांनी कार्यकर्त्यांसमवेत बुधवारी (ता. १०) वीज महावितरण पाली-सुधागडचे कार्यकारी उपअभियंता जतीन पाटील यांची भेट घेतली व सिद्धेश्वर शाळेचे वीज कनेक्शन चालू करण्यास सांगितले. यावेळी सुनील साठे यांनी सांगितले की हे सारकरा इतके निर्दयी झालेय की ग्रामीण भागातील मराठी शाळांचे वीज कनेक्शन कापून येथील विद्यार्थ्यांचे शैक्षणिक नुकसान करत आहे. याचा जाहीर निषेध करतो असे साठे म्हणाले. यावेळी मनसे तालुका अध्यक्ष सुनिल साठे, घनश्याम सितारपारव, सागर जाधव, रोहन साळुंखे आदी कार्यकर्ते उपस्थित होते.
