# Markets extend winning run to sixth day on tech boost

PRESS TRUST OF INDIA Mumbai, August 3

THE EQUITY BENCHMARKS staged a fag-end recovery to close in the green for the sixth straight session on Wednesday, propelled by IT counters and Reliance Industries amid continuous foreign fund inflows and a largely positive trend in global markets.

However, lacklustre macroeconomic data and a sharp drop in the rupee capped the gains, traders said.

In a volatile session, the 30share BSE Sensex ended 214.17 points or 0.37% higher at 58,350.53. During the day, it hit a high of 58,415.63 and a low of 57,788.78.

The broader NSE Niftywent up by 42.70 points or 0.25% to 17,388.15.

Tech Mahindra was the top gainer in the Sensex pack, spurting 1.97%, followed by TCS, Infosys, Titan, Asian Paints, ICICI Bank, Bharti Airtel and Reliance Industries.

On the other hand, Maruti

Suzuki, Sun Pharma, Kotak Mahindra Bank, IndusInd Bank, Bajaj Finance and ITC were among the laggards, shedding as much as 2.29%.

"Market has rebounded strongly with a turn in the trajectory of foreign investor flows — the last 4 sessions have seen FPI inflows of nearly \$1 billion. A perceived pivot in the Fed's tightening cycle and cooling off of crude oil prices have made the macro environment more favourable for India, which has outperformed EM and Asian peers by 6% in the last week.

"Going forward, the gap in

valuations between Nifty and MSCI Emerging Markets index, as well as the gap between the earnings yield of Nifty vs 10 year G-Sec yield, would be adverse factors and we can expect market returns to be more muted," said S Hariharan, head- sales trading, Emkay Global Financial Ser-

In the broader market, the BSE mid-cap gauge dipped 0.60% and the smallcap index fell 0.28%.

Among the BSE sectoral indices, IT climbed 1.28%, followed by teck (1.13%) and finance (0.02%). Telecom, capital goods, realty, auto, basic materials, FMCG and industrials were among the laggards.

India's services sector lost momentum in July as demand was curtailed by competitive pressures, elevated inflation and unfavourable weather, a monthly survey said on Wednesday.

The seasonally adjusted S&P Global India Services PMI Business Activity Index fell from 59.2 in June to 55.5 in July, pointing to the slowest rate of growth in four months.

World markets held steady despite heightened geopolitical tensions following US House Speaker Nancy Pelosi's visit to Taiwan amid vociferous protests by China, which views the island as a breakaway province.

In Asia, markets in Seoul, Tokyo and Hong Kong ended higher, while Shanghai settled in the red, European stocks were trading in the positive zone during mid-session deals. The US markets had ended lower on Tuesday.

# AU SFB launches QIP with floor price of ₹590.84

### JAIPUR-HEADQUARTERED

**AU SMALL** Finance Bank (SFB) on Wednesday launched a qualified institutional placement (QIP) to raise up to ₹2,500 crore, with a floor price of ₹590.84 per share.

The SFB may offer a discount of not more than 5% on the floor price calculated for the issue, it said in a communication to the stock exchanges. In a separate notification, the lender said promoter, MD & CEO Sanjay Agarwal intends to sell up to 75 lakh shares of the bank. As a result of the sale, the shareholding of the promoters and the promoter group will come down to 27.02% from 28.21%.

AU SFB's shares ended at ₹609.35 on the BSE on Wednesday, down 1.42% from their previous close.

Of the shares to be sold by Agarwal, up to 50 lakh will be sold for his family and personal financial needs and the

remaining 25 lakh are to be sold by MYS Holdings, member of the promoter group of the SFB, in order to contribute to social and philanthropic causes, the notification said.

"The above-mentioned sale

is to be carried out only post the completion of any private placement, preferential issuance, public offering or any other offering if undertaken in the next two months from the date of this letter, and such sale will be made at or above the price that may be finalised for issuance of equity shares in the offering and it shall be subject to receipt of pre-clearance and approvals as required under the Code of conduct - Prohibition of Insider Trading Policy of the Bank and under SEBI (Prohibition of Insider Trading) Regulations, 2015, and other requisite approvals as may be required in this regard," Agarwal said in a communication to

the exchanges. A meeting of the capital raising committee of AU SFB is scheduled for August 8.

# LIC listing pushes govt ownership in NSE firms to 7.15%

THE LIC SHARE sale — the largest issue despite being a highly trimmed down one, has pushed the government holding in listed companies to a high of 7.15% in the June quarter from 5.48% in the March quarter.

But in value terms, the government holding in the NSE companies jumped by 20.24% to ₹16.99 trillion — primarily due to the LIC issue, which is now valued as the 10th largest in terms of market capitalisation of ₹4.29 trillion — in the

June quarter. It was ₹14.13 trillion in March 2022, according to an analysis by Prime Database. This is way lower than the value of Reliance Industries which has a market cap of ₹17.63 trillion.

According to Pranav Haldea, managing director of Prime Database Group, this was primarily on account of the ₹20,557-crore LIC IPO in May (which is only around a third of what was initially planned, selling only 3.5%).

For the past 13 years, the share of the government in listed companies has been steadily declining.
