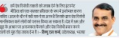

BSY blinks...

Soon after, he walked over to the next-door Raj Bhavan to hand in his resignation to Governor Thawar Chand Gehlot. The four-time CM who never completed a full term in office, will continue to be a caretaker CM till a nominee is named. Asked about this, he said Delhi will decide. "I thank PM (Narendra) Modi, Amit Shah and JP Nadda. They gave me the chance to rule as Chief Minister despite being over 75. I had decided to resign some time back. I thought it best to resign today as we mark completion of two years in this term," he told reporters. "Nobody pressured me to resign. I did it on my own so that someone else can take over as Chief Minister after the completion of two years of government. I'll work to bring BJP back in power in the next election. I've not given name of anyone who will succeed me," Yediyurappa added.

6 Assam...

"I immediately cannot say how many people have been injured, but my guess is at least 50 personnel. Our SP was also injured in the firing and a bullet hit his leg," the officer said over the phone. **Shah calls Assam, Mizoram CMs:** Union Home Minister Amit Shah on Monday spoke to the CMs of Assam and Mizoram over the ongoing border row between the two states and asked them to ensure peaceful resolution of the dispute, sources said.

4 life terms...

The incident had led to public outrage. The BJP as well as Congress accused each other of getting involved in the crime. Later, Satna Police, with help of their counterparts in Uttar Pradesh, identified the accused and arrested six persons including the tutor of the twins. During the interrogation, the accused confessed to having killed the twins and dumping the bodies in the Yamuna river in bordering Banda district of Uttar Pradesh. The bodies were later recovered from the river. The accused are Raju Dwivedi, Padam Shukla, Lucky Singh, Vikramjeet Singh, Ramkesh Yadav and Apurv Yadav. Ramkesh Yadav, who was the tutor of the twins and kingpin of the crime, had committed suicide by hanging himself in Satna Central jail on May 8, 2019. On Monday, all five accused were produced before the court of ADJ Pradeep Kachhwha who found them guilty and awarded them the double life term. While Raju Dwivedi, Padam Shukla, Lucky Singh have been awarded life sentence four times and imposed Rs 1.70 lakh each as penalty, the court has given double life terms to Vikramjeet Singh and Apurv Yadava and also imposed a penalty of Rs 65,000 on each.

More muck at...

As The Wire and its Pegasus Project partners have maintained, unless the phones are technically examined, it is difficult to ascertain if the numbers from the potential list were actually infected. The Wire won't be able to confirm if Singh and his family were actually subjected to surveillance. The leaked records indicate that the telephone number of a senior employee of the NITI Aayog - the Union government's policy think-tank - was also included as a probable target for surveillance. **KEJRIWAL'S AIDE:** The Pegasus Project list also includes the phone number used by V.K. Jain, who was appointed as chief consultant at Delhi chief minister Arvind Kejriwal's office. Jain's phone number appeared in the leaked records in 2018, when, according to sources in the Delhi government, he handled the most significant files of the state government.

You dont...

The Tokyo Organising Committee of the Olympic and Paralympic Games conducted the "Tokyo 2020 Medal Project" to collect small electronic devices such as used mobile phones from all over Japan to produce the Olympic and Paralympic medals. In the two years between April 2017 and March 2019, 100 per cent of the medals required to manufacture the approximately 5,000 gold, silver and bronze medals were extracted from small electronic devices contributed by people from all over Japan. Every medal being awarded to athletes during the Games is made from recycled metals.

Efforts to be...

He said, "Our brothers and sisters living in tribal areas of the state can get employment and livelihood. With this aim 'Devaranya' yojana has been prepared. This scheme will be implemented at a fast pace." Ministers, senior officials, representatives of various AYUSH pharmaceutical companies and other experts were present in the workshop organised by the State Policy and Planning Commission. The CM said the state government would develop a complete value chain of production of AYUSH medicines in the state through Devaranya Yojana. Self-help groups would also play an important role in this work. In this, agriculture producer organizations, departments of AYUSH, Forest, Rural Development, Horticulture, Tourism, Agriculture, Micro, Small and Medium Enterprises, Industrial Policy and Investment Promotion and Tribal Affairs Departments would work together in mission mode. Referring to the 'vaidya' of his village Raghuveer Prasad, Chouhan said he used to diagnose the disease by seeing the pulse and give medicine. Deputy chairman of State Policy and Planning Commission Prof Sachin Chaturvedi said AYUSH-based scheme had been prepared to strengthen the livelihood resources and employment generation of the residents of scheduled tribal areas in the state. Union secretary AYUSH Rajesh Kutecha said there was a huge market for AYUSH medicines in the world. India was the largest producer after China in this area. Presently there was a great demand for raw material i.e. medicinal and aromatic plants for this. Industries had given advance orders for this. The tribes knew how to conserve and increase the production of these plants. Dabur India CEO Mohit Malhotra said Amla was in high demand for Ayurvedic medicines. It was supplied in large quantity from Madhya Pradesh. With the promotion of medicinal crops, if organic certification of these crops was done, then it would be very beneficial. Gulraj Bhatia of Emami Health Care said in the next 15-20 years there would be immense potential in the field of AYUSH. For this, cooperative farming of medicinal and aromatic plants should be promoted in the state. Rajiv Vasudevan, CEO, Ayurveda Group of Hospitals, Bangalore said Ayurveda could cure all diseases. For this, a strong system of Ayurveda treatment should be developed at the district level from the primary health centres. 'Hitraksha Pramukh' of Vanvasi Kalyan Ashram Girish Kuber said knowledge of ancient flora was with the tribes. Ranjit Puranik of Dhootpapeshwar Limited, Mumbai said Madhya Pradesh was not only the heart of India but also a 'Green Lung'. There was a vast store of medicinal plants and herbs here. Neemuch was the global mandal of Ashwagandha. Panna's Amla was the best in the country. Gajanan Dange, President, Center for Research and Strategic Planning for Sustainable Development Pune said along with community development, individual patas should be provided to forest dwellers. Ashok Varshney of Aarogya Bharati said tribal people should be encouraged and made aware for the conservation and production of medicinal plants.

Rahul drives tractor to Parliament over farm laws

NEW DELHI

Coming out in support of protesting farmers, former Congress Chief Rahul Gandhi on Monday drove a tractor to Parliament and reiterated his demand of withdrawing the three new farm laws.

Rahul Gandhi along with several party members drove the tractor, which had a big board on the front on which was written in Hindi - Take back the three anti-farmer laws.

Speaking to the media, Rahul Gandhi said, "I have brought farmers' message to Parliament. They (Government) are suppressing voices of farmers and not letting a discussion take place in Parliament."

He said that they'll have to repeal these black laws. "Entire country knows for whose benefit this (three farm laws) is being done. This is not in favour of farmers and the government will have to withdraw these three black farm laws," he said.

Targeting the government, the Congress MP from Kerala's Wayanad said, "As per the government, farm-

ers are very happy and those (protesting farmers) sitting outside are terrorists. But in reality, farmers' rights are being snatched away."

Rahul Gandhi drove the tractor from Motilal Nehru Marg to Parliament via Red Cross road. The Delhi

Police then detained Congress spokesperson Randeep Singh Surjewala and Youth Congress national President Srinivas B.V. along with scores of party workers. They were taken to the Mandir Marg police station in Central Delhi.

Farmers to launch stir in UP, Uttarakhand

Occupying Delhi borders in protest against the farm laws for the last eight months, the farmers will now launch massive agitation in Uttar Pradesh and Uttarakhand. The joint front of farmers made this announcement in Lucknow on Monday and named it Mission UP & Uttarakhand.

The joint front will start the agitation with a grand rally of farmers in Muzaffarnagar, UP, on September 5 and after this, similar programmes would be organised in every division of the state. During the agitation, the farmers would raise the demand for withdrawal of three farm laws, guarantee of minimum support prices and other issues related to UP & UK.

While making this announcement in the state capital on Monday, Rakesh Tikait of Bharatiya Kisan Union (BKU), Yogendra Yadav of Jai Kisan Andolan, Shiv Kumar Kakka of Rashtriya Kisan Majdoor Mahasangh and Dr

Ashish of All India Kisan Majdoor Sabha said that their movement in Delhi has completed eight months and now it has been decided to launch Mission UP & UK. The farmers joint front has demanded that all the toll plazas in UP & UK be abolished. The front has called upon the farmers to demonstrate at the offices of Ambani and Adani group.

According to Rakesh Tikait, a massive panchayat of farmers would be called at Muzaffarnagar in western UP on September 5 and after this, it will be organised in every division of the state. He said that the joint front has decided to raise local issues related to farmers in their agitation along with the national ones.

He said that farmers in UP are suffering a lot and they are being denied proper rates for their produce. Citing example of wheat procurement farmer leaders said that Yogi Government has been claiming to have made record purchase but the fact is that it has only procured 18 per cent of the total production.

SC REFUSES TO STAY PROCEEDINGS AGAINST GAMBHIR FOUNDATION

The Supreme Court on Monday refused to stay the proceedings against BJP MP Gautam Gambhir's foundation in a case relating to illegally procuring and distributing COVID-19 medicines.

A bench comprising Justices D

Y Chandrachud and M R Shah said people were running around for medicines and drugs, and in this situation suddenly a trust comes and says we will give you medicines.

"This is not done. We do not want to say anything but we also have our ears to the ground," the bench observed while refusing to entertain the plea. The apex

court asked the petitioner to approach the Delhi High Court and seek appropriate remedy.

"Kailash Vasdev, learned senior counsel appearing on behalf of the petitioners states that the petitioners are advised to withdraw the Special Leave Petition so as to enable them to move the High Court for impleadment in the pending proceedings. The

Special Leave Petition is dismissed as withdrawn," the plea said.

Vasdev, appearing for the foundation, sought a stay on the prosecution under the Drugs and Cosmetics Act.

On sensing disinclination of the bench, the counsel for the Gambhir's foundation withdrew the petition.

Delhi's drugs control department had on July 17 told the Delhi High Court that it has launched prosecution against Gautam Gambhir Foundation and AAP MLAs, Imran Hussain and Praveen Kumar, before a court for allegedly illegally stocking and distributing Covid drugs during the infection's second wave.

Sidhu holds first meeting as Punjab Cong chief

CHANDIGARH: Days after taking charge as the Punjab Congress chief, Navjot Singh Sidhu on Monday held his first meeting with four working presidents and representatives of different wings of the party's state unit.

Sidhu had detailed discussions with four working presidents about rebuilding the organisation and further strengthening the party at the grassroots level, the party said.

He also met representatives of the party's frontal organisations and cells including Youth Congress, NSUI, SC cell, BC cell and Legal cell and heard their views at the Punjab Congress Bhawan here.

Sidhu also learnt from them the details of their working and how they can play a pivotal role to further strengthen the organisation, the party said.
