The Trustees of Sreeji Family Benefit Trust (“SFB Trust”) are directly holding 3,50,27,053 (8.09%) equity shares of the Target Company. Certain promoter companies namely, G. K. Investments Ltd., Murari Investment & Trading Co. Ltd., Uttam Commercial Co. Ltd., G K & Sons Pvt. Ltd., Electrocast Sales India Ltd. The aforesaid equity shares of the Target Company and the said Promoter Companies are currently held by the two existing Managing Trustees i.e., Mr. Umang Kejriwal and Mr. Mayank Kejriwal, in equal proportion and in two separate demat accounts, for the benefit of the beneficiaries of SFB Trust. It is now proposed that Mr. Umang Kejriwal shall retire as Managing Trustee of SFB Trust and Smt. Asha Kejriwal, who is already an existing Trustee of SFB Trust, shall be appointed as the new Managing Trustee of SFB Trust.

As a result of the aforesaid change in the Managing Trusteeship of SFB Trust, the aforesaid equity shares of the Target Company and the said Promoter Companies lying in the demat account held by Mr. Umang Kejriwal, the Retiring Managing Trustee shall be transferred to the demat account held by Smt. Asha Kejriwal, the New Managing Trustee.

Thus, I, **Asha Kejriwal**, as the New Managing Trustee of SFB Trust, intend to acquire the following from Mr. Umang Kejriwal, the Retiring Managing Trustee of SFB Trust:

- 1,75,13,527 (4.05%) equity shares of the Target Company; and
- Such number of equity shares of the Promoter Companies which are held by Mr. Umang Kejriwal as a Managing Trustee of SFB Trust, resulting into indirect acquisition of 16,81,59,212 (38.84%) equity shares of the Target Company.
