- (i) The remuneration to the key managerial personnel does not include the provisions made for gratuity and compensated absences, as they are determined on an actuarial basis for the Company as a whole.
- (ii) Share based compensation expense allocable to key management personnel is Rs. 82 (Half year ended 31 March 2020: Rs.61) for the half year ended 31 March 2021, which is not included in the remuneration disclosed above.
- (iii) Effective from 1 October 2006, the Company has entered into an arrangement for lease of land on lease basis and a service agreement with 'Biocon SEZ Developer' of Biocon Limited for availing certain facilities and services. The facility charges of Rs. 74 (Half year ended 31 March 2020: Rs. 51) and power charges (including other charges) of Rs. 7 (Half year ended 31 March 2020: Rs. 83) have been charged by Biocon Limited for the half year ended 31 March 2021.
- (iv) All transactions with these related parties are priced on an arm's length basis and none of the balances are secured.
