I tried to pull out one of the reviews of films for The Mail, where SPB sang super hit songs like in Varumaiyin Niram Sivappu. I didn't write a very favourable review but the songs had their own charm. SPB's rendering of Sippi Irukkuthu and Theerthakarayinile (Bharathiyar), then made a great impact on the audience. My colleague D.S.Ramanujam from "The Hindu" always used to say about SPB, "Eppadi padranda", with great admiration.

The soul stirring golden voice of the versatile singer has millions of followers, cutting across age barriers and countries. Unfortunately, the great grand singing son of India has not stirred the anchors of the "so called" National TV channels.

The news of SPB's death was shockingly missing. Not even a scroll for this great soul in these short sighted channels! What a loss to their viewers.

There was a volcanic reaction in FB and other social media condemning these "National channels" and many recalled the pre (AIADMK-DMK) slogan, "Vadakkai Vazh-kirathu, therku theikirathu", (North is dominating, south is deteriorating). It is sad that this sad news has stimulated hatred for the Hindi and National Channels.

Sripathi Panditaradhyulu Balasubramanyam also fondly called as SPB or Balu is world renowned, appreciated and an admired playback singer, actor, music director and film producer. He won the hearts of millions with his unique mesmerizing songs. He rendered over 42,000 songs including some brilliant devotional songs. His style of rendering Lingashtakam- Brahm Murari is religiously adopted by devotees of Shiva on Pradosham day.

SPB has won National Film Awards across 4 languages. He is also the recipient of civil



ian awards like Padmashri(2001) and Padma Bhushan (2011) from the government of India.

SPB has the distinction of singing for over five decades for all the heroes from 1960s. He enhanced the profile of heroes like MGR, Gemini, Mohan, Kamal, Rajini, Sathya raj, Prabhu, Prabhu deva, Sharad Kumar, Karthik and also the leading heroes of today. SPB is also an instant singer with clarity. Undaunted he recorded as many as 19 songs on a single day- all pleasing melodies.

Some of the songs that are bewitching like "Peakudathu" from the movie Aduthu Varisu with Sushela. Illayaraja (1983) hit the roof with his instrumental blend and creativity in this song. The evergreen melody



"Marupadiyam" movie by veteran director Balu Mahendra is a good story. The Song from this movie, "Nalam Vaazaha ennaalum" is sung in all light music programmes. It is a super hit, hit that every youngster keeps singing even today. Nilave Vaa from the movie Mouna Ragam is so melodious that your heart will melt. SPB perhaps is the only singer in the world who has sung 19 songs in a day and completed 42,000 plus songs in 16 different languages.

Above all SPB is a good human being

with no ego and a good PR person. He was kind and very charitable. He made everyone around him feel at home. He showed his humility by honouring his contemporary K J Yesudas. In the movie 'Sigaram' for which he scored music, he gave the song 'Agaram ippo Sigaram'. Yesudas did a good job of it. After climbing the peak on his own merits in the murky movie world, he succumbed to Corona. Ironically he was confident that he would come back and also rendered a song on "Corona".

Millions are in tears with unbearable pain and unable to accept that he is no more. SPB will remain with us eternally through his chants, and melodies which will linger in the wind (kaatrinile varum getham) and in every home. May his soul rest in peace. With heavy heart of sadness.



Dinamalar Adimoolam elected INS president, minister greets

New team vow to fight for removing 5% duty on newsprint

New Delhi, Sept 26: At the 61st Annual General Meeting of Indian Newspaper Society, INS, Dinamalar Publisher L Adimoolam has been elected as president. Adimoolam will be taking over from Shailesh Gupta of Mid-Day.

Adimoolam who represents the leading Tamil daily was chosen unanimously at the meeting and it was recalled that in 1993 Daily Thaithi chairman Sivanthi Adithan was elected president.

Minister for Municipal Administration SP Velumani in his twitter message has greeted Adimoolam and has said that his elevation to adorn presidency of a national media body is a proud moment for Tamil Nadu.

D D Purkayastha of the Ananda Bazar Patrika was chosen as the Deputy President, Mohit Jain of The Economic Times as the Vice President and Rakesh Sharma of Aaj Samaj was elected as the Honorary Treasurer for the year 2020-21.

Mary Paul will be the Secretary General. In his presidential address, outgoing president Gupta said the

print media faced "unprecedented challenges" in recent times due to Covid-19 though the earlier part of the year showed signs of economic revival.

The Covid-19 lockdown led to a drop in both commercial and government advertising, which has acted the bottom lines of all, and the industry continues to "shrink" with several newspapers "gasping for breath". "Shrinking readership and advertisement revenues, rising costs and an onslaught of digital and social media have taken a huge toll on its financial health. There is thus an urgent need to reinvent, explore new revenue models, rective

cost-cutting measures and above all, improve the contents," he said.

He said the print media needs to emphasise on quality and credible journalism as advertisers have started to prefer their brands to be associated with credible news sources which was a positive trend. Highlighting the need for the complete withdrawal of 5% customs duty on newsprint, he also said that the industry has managed to impress upon the government to not impose a separate antidumping duty on newsprint, which has been advocated by the newsprint manufacturers. Gupta also found fault with the new Print Media Advertisement Policy, 2020, saying that it was "arbitrary, unjustified and discriminatory against the interests" of newspapers, especially from the small and medium categories. With the print media facing competition from the social media giants that defy the conventional definition of media, he said the INS has taken up the issue with Google India and Facebook to enable print media to get a fair share from the tech giants because they are using the content generated by others.
