4.	Steps taken for smooth functioning of operations	Exhaustive measures have been undertaken by the Company to ensure safe workplace for the employees with appropriate social distancing and high standard of hygiene. The Company has also taken various steps such as thermal screening of all employees and visitors, sanitizing the premises on regular basis, enforcing wearing of masks, asking all employees to have Arogya Setu App on their mobiles and continuously follow guidelines as prescribed by the Central or State Government from time to time. Work from Home option is also continued for certain category(s) of employees. The Company has also ensured complete adherence to all safety guidelines to minimize the spread of this deadly corona virus.
5.	Estimation of the future impact of COVID-19 on its operations	It is not easy to assess the full impact of COVID-19 with reasonable certainty, however currently, with the close down of the factories as stated above, have impacted the overall production of our Dyes & Intermediates divisions which contributes about 75% of our sales. Never the less our fertiliser Division, the Animal feed supplement, and the acid plant have started operations from 20 <sup>th</sup> April 2020 and are operating satisfactorily, As regards our Dyes & Intermediates division have been affected on account of paucity and irregularity of orders. Our business has thus been affected by Covid-19, to the extent mentioned. However, of late from the various orders slowly trickling in, we anticipate better operations from the 3 <sup>rd</sup> Qrt. However, in view of workers / employees from outside locations having dwindled, resulting in paucity of skilled workers, which also has posed problems for getting adequate skilled workers.
