

VCs unilaterally appointed by Guv are 'illegal entrants': Bengal education minister

KOLKATA, NOV 4 /-/- West Bengal Education Minister Bratya Basu on Saturday described the officiating vice-chancellors of universities appointed by Governor CV Ananda Bose without consulting the State government as "illegal entrants."

Basu justified the decision to exclude those officiating VCs in a symposium organised by the higher education department held in collaboration with CII. "The VCs should be appointed following discussions between the governor and the higher education department. The Supreme Court has already termed

the appointment of interim VCs by the governor without taking the state in confidence as illegal," the minister told reporters.

The department has invited to the symposium only those academics who were appointed as per law, he said. "We don't think any illegal entrant is needed here," Basu said. Governor Bose, who is the ex-officio chancellor of state-run universities, has appointed officiating vice-chancellors in 16 varsities. The post is still vacant in several other such institutes. Asked about the officiating Vice

Chancellor of Jadavpur University Buddhadeb Sau having convened a meeting of the Executive Council, the highest decision-making body of the varsity, Basu expressed disapproval of



any such move.

"If we have not been consulted about the EC meeting, and so far I remember, we have not been, that move by the university is violative of the Supreme Court's observation on the issue. I will again crosscheck if we have been intimated. And if I find we had not been kept in the loop, we will bring it to the notice of the Supreme Court," he said.

The apex court on October 6 had stayed the emoluments of newly appointed interim VCs of state universities in West Bengal. In an earlier ruling, it said it would set up a search committee to pick up VCs. About allegations by a theatre group in North 24 Parganas district that its bookings of a municipality-owned auditorium in Kalyani have been cancelled at the last moment after they staged an "anti-government" play in Kolkata, the minister said, "Theatre cannot be stopped, theatre will move on its own." Basu, an acclaimed theatre personality, however, added that he would talk to the chairman of Kalyani Municipality to know the reasons for cancelling the bookings before commenting further on the issue. 16 held in City for black-marketing of WC match tickets

KOLKATA, NOV 4 /-/- City police have so far arrested 16 people, registered 7 cases in different police stations and seized 94 tickets meant for Sunday's India-South Africa world cup match at the Eden Gardens as part of a drive to check alleged black-marketing of tickets, an officer said on Friday.

On Friday, officers of Kolkata Police's detective department grilled representatives of the online ticket booking portal in connection with allegations of black-marketing of tickets for Sunday's tie. However, no representatives of the Cricket Association of Bengal (CAB), who were also asked to report at Maidan police station in this connection, came forward, he added.

"Our officers spoke with portal officials today. But no CAB representatives came," the officer said, adding that they have served another notice to officials of the state cricket body to appear before them. Police had summoned officials of the

CAB and the portal following a complaint that tickets for the India-South Africa match were being black-marketed, an officer said. Police on Friday arrested three persons from Netaji Nagar here for allegedly black marketing tickets for the match, he said, adding that 17 tickets were seized from them.

"The arrested persons were allegedly selling Rs 900 ticket for Rs 8,000. In all, 17 tickets have been recovered from the arrested persons," he said, adding that they were arrested under various sections of the IPC. A case under the WB Black Marketing Act 1948 has been lodged against the trio and officials of the portal and CAB.

On Thursday night, police arrested two from Dharmatala for alleged black-marketing of tickets and seized eight tickets from them. Acting on a separate complaint, Hare Street police arrested a person for duping a man in the name of selling match tickets, he added. The first case of

black marketing was registered at Maidan police station on Wednesday after a complaint was received that tickets were being sold at astronomical figures "owing to the connivance of an online portal along with officials of the CAB and Board of Control for Cricket in India (BCCI)" for the India-South Africa match on Sunday, he said.

The officer said raids will continue to keep a check on the black marketing of tickets. "Our officers are alert and raids will continue," the officer told PTI. The complainants alleged that certain BCCI and CAB officials, along with the online ticket booking portal, intentionally reserved a good number of tickets meant for the general public and made those available to black-marketers. A senior CAB official rubbished the allegations and said they were only hosting the match and had no involvement in the selling of tickets which was looked after by the portal and the International Cricket Council (ICC). Face authentication submission of DLC to make certificate submission easier for pensioners

KOLKATA, NOV 4 /-/- To enhance 'Ease of Living' of Central Government pensioners, Department of Pension & Pensioners' Welfare (DOPPW) has been promoting Digital Life Certificate (DLC) i.e. Jeevan Pramaan extensively.

In 2014, submission of DLCs using biometric devices was commenced. Subsequently, the Department engaged with MeitY and UIDAI to develop a Face Authentication technology system based on Aadhar database, whereby it is possible to submit LC from any Android based smart phone. As per this facility, the identity of a person is established through face authentication technique and DLC gets generated. This breakthrough technology, launched in November 2021, reduced the dependence of pensioners on external bio-metric devices and made the process more accessible and affordable to masses by leveraging smart phone based technology.

With a view to spread awareness amongst all the Central Government pensioners as well as the Pension Disbursing Authorities for use of DLC/Face Authentication technology to submit Digital Life Certificate, DoPPW launched a nation-wide



campaign in November, 2022. The campaign was a huge success with more than 35 lakh DLCs of Central Government Pensioner issued. A Nation-wide Campaign is being held from from November in 500 locations in 100 cities across the country, targeting 50 lakh pensioners in collaboration of 17 Pension disbursing banks, Ministries/ Departments, Pensioners' Welfare Association, UIDAI, MeitY. In order to ensure that the benefit of digital modes of Life Certificate submission reaches pensioners in the remotest corners of the country and also benefits super senior/ sick / incapacitated pensioners, a set of comprehensive guidelines have been issued by the Department.

Trinamool MP slams arrested minister, labels him 'traitor'

KOLKATA, NOV 4 /-/- Senior TMC leader Kalyan Banerjee has labelled party colleague and arrested minister Jyotipriyo Mallick as a "traitor" and asserted that the party's leadership cannot be held accountable if a party functionary engages in corruption. The Enforcement Directorate (ED) had arrested the West Bengal minister last week in connection with a money laundering case linked to an alleged multi-crore ration distribution scam in the state. While being transported to the hospital for a health check-up, Mallick claimed that the BJP had conspired against him to frame him on false charges. He also asserted that the party's top leadership is aware of this conspiracy and firmly supports him.

Mallick said, "The BJP is behind my arrest. They have conspired against me. My party leadership is aware of it (the conspiracy). The party is with me."

Banerjee was incensed by the arrested TMC leader's reference to the party's top leadership, stating that the party's senior members cannot be blamed if a party functionary engages in corruption. Banerjee told a news channel, "Why bring the party's top brass into everything? The party has entrusted someone with a responsibility, whether it's a

ministerial position or any other role, but if that individual indulges in corruption, then the party cannot be held responsible. The individual must take their own responsibility." "If someone is trying to drop names, then he or she is a traitor," the TMC's Lok Sabha Chief whip said. Incidentally, the party had staunchly supported Mallick and labeled his arrest as "vendetta politics." (PTI)

Strong tremors felt in several Bihar and Jharkhand, none hurt

PATNA, NOV 4 /-/- Strong tremors were felt in several districts of Bihar as an earthquake of magnitude 6.4 struck neighbouring Nepal, officials said on Saturday. However, no loss of life or damage to property was reported in the state. According to the Bihar Disaster Management Department, the tremors were felt in Patna, Katihar, East Champaran, Darbhanga, Muzaffarpur, West Champaran, Sasaram, Nawada and several other districts along the India-Nepal border. "There were no reports of any loss of life or damage to property due to the earthquake," the department said in a statement issued here on Saturday. However, the department issued helpline numbers 0612-2294204, 2294205, 7070290170 for any queries or assistance related to the earthquake. The National Centre for

Seismology said the epicentre of the earthquake, which struck around 11.30 pm on Friday, was in Jajarkot district of Nepal, about 227 km north of Ayodhya and 331 km west northwest of Kathmandu, resulting in the death of at least 128 people. The impact of the quake was felt in Kathmandu and surrounding districts. Jajarkot and Rukum districts in western Nepal were worst hit by the quake. In Bihar, the tremors triggered panic among people, who rushed out of their houses in various localities of Patna, Katihar, Nawada, Muzaffarpur and Dabhanga as a precautionary measure. The earthquake was also felt across parts of north India, including the national capital region, the officials added. This was the third time in a month that strong quakes have struck Nepal.

Several districts of Jharkhand felt mild tremors due to the 6.4 magnitude earthquake that hit Nepal, officials said on Saturday. However, there was no report of loss of life or property in any part of the state. Ranchi, Hazaribag, Garhwa, Koderma, Ramgarh and some other parts of the state experienced mild tremors on Friday night. The mild jolts triggered panic among people. Residents of Ranchi claimed they experienced jolts two times for around four to five seconds. "Jharkhand experienced mild tremors, caused by the earthquake in Nepal," Ranchi Meteorological Centre in-charge Abhishek Anand told PTI. The National Centre for Seismology said the epicentre of the earthquake, which struck around 11.30 pm, was in Nepal, about 227 km north of Ayodhya and 331 km west-northwest of Kathmandu. (PTI)
