However, our requests have gone unanswered and no information in this regard has been provided to us, thus we are constrained from making any disclosure in this regard. On account of the foregoing, the related party transactions entered into by 48 Networks are not included in the disclosure. In any event, please note that Info Edge has, through the publication of its standalone and consolidated financial results for Q1 of FY 2022-23, written down its entire investment of INR 276,00,00,000 (Indian Rupees Two Hundred Seventy Six Crores) in 48 Networks and the said investment was charged to an exceptional item in the financial results.
