In this regard we would like to state that our Company has been making timely disclosures of all the events, information etc that have a bearing on the operations/performance of the Company which includes all Price Sensitive Information. Similarly, the Company has recommended Final Dividend Re. 1.00/- per equity share (i.e. 10%) of face value of Rs.10/-each fully paid for the year ended March 31, 2024, subject to the approval of the shareholders at the ensuing Annual General Meeting (AGM).

Moreover, the Company had conducted Investor and Analyst Call on May 15, 2024, wherein the detailed presentation that has upcoming business plans of the Company was shared. The audio recording along with the transcript was duly furnished to the BSE Ltd.
