With reference to your letter and email dated October 27, 2022 seeking clarification regarding the recent news item which appeared in the "www.businessstandard.com" dated October 27, 2022 captioned "Aviation watchdog DGCA issues aerodrome licence for Goas Mopa airport". In this regard we wish to inform you that GMR Goa International Airport Limited (GOA Mopa Airport) is in the advance stage of project completion and is in the process of obtaining various licenses as per the statutory requirements in normal course of business towards readiness for airport operations.
